INTRODUCTION

I, Bhagwan Dass, MLA, Chairperson of the Committee on the Welfare of Scheduled Castes, Scheduled Tribes and Backward Classes, having been authorized by the Committee in this behalf, present this 48th Report on the following matters:-

- (i) On the representation/backlog to the Scheduled Castes and Backward Classes, in recruitment & promotion as per their reservation criteria, in the Government services;
- (ii) On the matter of atrocities i.e. compensation to the aggrieved person in atrocities cases & rate of convictions thereupon, Mukhya Mantri Vivah Shagun Yojana, allotment of 100 sq. yard plots to the Scheduled Castes categories, Stipend /Post Matric Scholarship to the students of reserved categories and utilization of the budget/funds of the component plan relating to the Scheduled Castes categories by the Agriculture and Farmers Welfare Department, Pradhan Mantri Awas Yojana, facilities to the colonies constructed under the Mahatma Gandhi Gramin Basti Yojna, homeless people of the SC categories alongwith utilization/non-utilization of budget and pending applications, information relating to the District wise details of repair of the house of BPL families, construction of the roads in the rural areas /colonies relating to the Scheduled Castes categories as well as to clear the backlog in appointment and promotion of employees in all the Departments/ Boards/ Universities/ Corporations etc. of the State of Haryana.
- (iii) On the implementation of the recommendations of the Committee regarding the Central/State Government's share Schemes applicable for the Welfare of the Scheduled Castes and Backward Classes in the various departments.
- (iv) Brief Reports of the Committee, upon the subject matters of study tours to the Union Territory of Jammu & Kashmir & State of Goa.
- (v) Various representations/complaints etc. take up by the Committee.

The Committee examined the Administrative Secretaries/ representatives of various Departments. Accordingly, the Report is based on the replies furnished by the concerned Departments/Autonomous Bodies, explanations and clarifications received during deliberations etc. The paragraph (s) recommendations (s) which have not been included in this Report have been dropped/disposed off by the Committee after fully satisfied from the replies submitted by the concerned departments.

A brief record/proceeding of each meeting have been kept separately in the Haryana Vidhan Sabha Secretariat.

The Committee wishes to express their thanks to the Administrative Secretaries/representatives of the concerned Departments who appeared before the Committee for oral examination in regard to the matters explained above.

The Committee is thankful for the whole hearted and unstinted co-operation extended by the Hon'ble Speaker/Secretary/Officer of the Committee and staff etc.

REPORT

The Committee on the Welfare of Scheduled Castes, Scheduled Tribes and Backward Classes for the year 2024-2025, which was worked upto 12th September, 2024 as on such day 14th Assembly was dissolved, was constituted on dated 29th March, 2024 by the then Hon'ble Speaker authorized by the House on a motions passed by the Haryana Legislative Assembly in its sitting held on dated 22nd February, 2024, for nominating the Members of the Committee and also for appointing the Chairperson of the said Committee. Shri Satya Parkash the then M.L.A. was appointed as Chairperson of the previous Committee.

On constitute of 15th Assembly, the such Committee on the Welfare of Scheduled Castes, Scheduled Tribes and Backward Classes for the remaining period for the year 2024-2025 was constituted on 23rd November, 2024, by the Hon'ble Speaker authorized by the House on a motions passed by the Haryana Legislative Assembly in its sitting held on dated 13.11.2024, for nominating the Members of the Committee and also for appointing the Chairperson of the said Committee, Shri Bhagwan Dass, MLA was appointed as Chairperson of the Committee.

The previous & present Committees held total 46 sittings till date of the finalization of this 48th Report. The first meetings of the previous & present Committees were held on dated 03rd April, 2024 & 2nd December, 2024, respectively, which were addressed by the Under Secretary who explained the scope and functions of the Committee in detail. The Chairpersons while thanking the Hon'ble Speaker for nominating them as the Chairpersons of the Committees and also assured that with the cooperation of the other Members and Officer/officials, the Committee will work a lot for improving of down-trodden sections of the society.

Representation to the Backward Classes Categories in the recruitment and facilities providing to such categories.

The previous Committee was take up the matter relating to Backward Classes categories and upon the recommendation and observation which were inserted in the 47th report of the previous committee, the Director General, Social Justice, Empowerment, Welfare of Scheduled Castes & Backward Classes & Antyodaya (SEWA) Department has supplied the reply vide letter dated 13.05.2024, which was placed before the Committee in its meeting held on 24.02.2025. After examine the reply, the Committee was not satisfied therewith and decided to orally examine the departmental representative of the said department in one of its subsequent meetings. Therefore, such matter is treated as pending.

Reservation/backlog in recruitment and promotion to the employees of Scheduled Castes categories all the Department/Boards/Universities/Corporations etc. of the State of Haryana.

The Previous Committee was take up the matter in respect of the reservation/backlog in recruitment and promotion to the employees of Scheduled Castes categories in all the Department/ Boards/ Universities/ Corporations etc. of the State of Haryana. Upon the recommendation/ observation of the previous committee, the Principal Secretary to Govt. Haryana, Social Justice, Empowerment, Welfare of Scheduled Classes & Backward Classes & Antyodaya (SEWA) Department furnish the reply vide UO dated 28.06.2023, but the committee was not satisfied with the contents of the reply and department was again asked vide letter dated 23.01.2024 to submit the latest information/reply. Till the presentation of the 47th report of the previous committee, the department could not supply the requisite information/reply.

Upon the recommendation and observation of the previous committee inserted in the 47th Report which was supplied to the above said department vide letter dated 21.03.2025 and two reminders on dated 26.07.2024 &12.12.2024 were also given with the request to submit the reply/requisite information. The Director General, Social Justice, Empowerment, Welfare of Scheduled Classes & Backward Classes & Antyodaya (SEWA) Department has supplied the amended reply on dated 13.12.2024, which was placed before the Committee in its meeting held on 03.02.2024. After examine the reply, the committee was not satisfied being the reply was incomplete.

The Committee is disappointed to note that till the finalization of the present report, the department not supply the requisite complete information. Therefore, such matter is treated as pending.

Implementation of the 85th amendment of Constitution

The Previous Committee was take up the matter of 85th amendment of the Constitution which was not implementing in true spirit. Upon the recommendation and observation of the previous committee the matter was referred to the Advocate General Haryana and the Chief Secretary to Govt. Haryana to furnish their replies in respect of implementation of the said 85th amendment. The Advocate General Haryana and some other departments to whom the Chief Secretary to Govt. Haryana issue the direction to furnish their replies directly to the committee, have furnish their replies which were placed before the previous committee in its meetings held on dated 20.09.2023 and 07.02.2024. The committee was only satisfied with the replies of Secretary Board of School Education, Superintendent Engineer Administration & DHVBN but the committee was not satisfied with the rest of replies. Till the presented of the 47th report, the previous Committee could not take up the matter.

Now such pending matter was brought to the notice of the present Committee in its meeting held on dated 24.02.2025 and Committee minutely examine the matter and observed that such matter is very important and the same may be take up in the subsequent meetings by the committee which will be constituted for the year 2025-26.

The District wise details of financial assistance given by the government for repair/maintenance of the houses to the BPL families.

The previous Committee (2023-2024) was take up the matter of maintenance/repairing of the House of the BPL families in its meeting held on dated 18.01.2024.

Upon the recommendation and observation of the Committee which were conveyed vide letter dated 23.01.2024, the Director General, Social Justice, Empowerment, Welfare of Scheduled Castes & Backward Classes & Antoyodaya (SEWA) Department furnish the reply vide letter dated 27.05.2024, which was placed before the Committee in its meeting held on 19.06.2024. After examine the reply, the Committee was observed as under:-

"the committee observed that a nominal number of the applications have been benefited out of the total applications of 3,56,573. The committee took a serious note in this regard and directed to the concerned officers of the department to takeup the matter seriously and submit the comments upon of not given the benefits to all the applicants so far."

Such recommendation/observation was again referred to the department vide letter dated 09.07.2024 with the request to submit the report in this regard. In reference to that the department furnish the information vide memo dated 07.08.2024 which was placed before the Committee in its meeting held on dated 24.02.2025.

The Committee minutely examine the contents of the reply, The Committee was satisfied with the reply and decided to drop the matter.

Utilization/non utilization of budget allotted under the Scheduled Caste component plan from the year 2017- 2018 to 2022-2023.

The Previous Committee was take up the matter of utilization/non utilization of the budget of Scheduled Castes component Plan which is not utilizing properly for the Welfare of the peoples of the SC categories in respect of reserved and unreserved constituencies. Upon the recommendation and observation of the previous committee, it was asked to the Social Justice, Empowerment, Welfare of Scheduled Classes & Backward Classes & Antyodaya (SEWA) Department vide letter dated 19.05.2023 to supply the requisite information as per enclosed proforma but inspite of given the two times reminder thereupon, the department failed to supply the requisite information till the presented of the 47th report of the previous Committee.

Now upon the recommendation/observation which have been inserted in the 47th report of the previous committee, the above said department submit the reply/information vide letter dated 12.04.2024 which was placed before the present Committee in its meeting held on dated 19.06.2024. The Committee minutely examine the reply and observed that the reply is incomplete, therefore, the Committee was not satisfied with the reply. The Committee directed to the officer of the department to furnish the complete information within 15 days positively. Thereafter, the department furnish the fresh information vide memo dated 07.08.2024 which was placed before the Committee in its meeting held on dated 21.08.2024. The committee examine the reply of the department and decided to conduct an oral examination of the Additional Chief Secretary to Govt. Haryana of the department in the subsequent meetings but till the presented of such report, the committee could not take up the matter and now same may be take up by the Committee which will be constituted for the year 2025-26.

Representation of Shri Roshan Lal, President, Haryana Pradesh Akhil Bhartiya Ambedkar Mahasabha (Regd.) Distt. Yamunanagar.

Shri Roshan Lal, President, Haryana Pradesh Akhil Bhartiya Ambedkar Mahasabha (Regd.), District Yamunanagar submit the representation to the Committee in its meeting held on dated 05.07.2023 regarding formulate the Haryana State Scheduled Castes and Scheduled Tribes Development Fund (Planning, Allocation & Utilization of Financial Resources) Act. 2023, for the Welfare of Scheduled Castes and Scheduled Tribes People. The representation was placed before the Committee and after examine the contents of the representation, the previous Committee accepted the same with the recommendation to refer the representation to the Social Justice Empowerment, Welfare of Scheduled Castes & Backward Classes & Antyodaya (SEWA) Department. As per recommendation of the previous Committee the representation was referred to the said department vide letter dated 17.07.2023 and in reference to the said letter, the said department furnish the reply of the representation vide memo dated 21.08.2023 which was placed before the previous committee in its meeting held on dated 20.09.2023, after examine the reply, the committee was not satisfied with the contents of the reply of the department. Upon the further observation of the previous committee the above said department was again asked vide letter dated 22.09.2023 and subsequent reminder dated 22.01.2024 to furnish the complete department wise requisite information upon utilization of the budget of scheduled caste component plan, but the previous Committee was disappointed to note that the department failed to supply the requisite information/comments till presented of 47th report.

The relevant part of the 47th report was supplied to the Social Justice, Empowerment, Welfare of Scheduled Castes & Backward Classes & Antyodaya (SEWA) Department vide letter dated 06.03.2024 with the request to submit the reply kipping in view of recommendation/observation of the Committee. Thereafter, the said department furnish the reply vide letter dated 16.04.2024, which was placed before the Committee in its meeting held on dated 19.06.2024. The Committee minutely examined the reply and the Committee was not satisfied with the contents therein. Now the Committee recommended to formulate an Act like wise the states of Andhra Pradesh, Orisa & Rajasthan for planning allocation and utilization of financial resources of the Special Component Plan for Scheduled Castes and Backward Classes. The Committee also directed the Officer of the Committee to refer the matter to the Government to enact an Bill for the purpose.

A letter dated 09.07.2024 & reminder dated 12.12.2024 were sent to the above quarter concerned for supplying the latest requisite information in details within fortnight from the receipt of this communication in this regard. Thereafter, the Director General, Social Justice, Empowerment, Welfare of Scheduled Castes & Backward Classes & Antoyodaya (SEWA) Department furnish the reply vide letter dated 05.02.2025 by intimating that the matter to formulate the bill in this regard is under consideration with the department, which was placed before the Committee in its meeting held on dated 17.02.2025. After examine the reply, the Committee noted the comments given by the department. Now the Committee decided to take up the matter in the subsequent meetings as to formulate the bill in this regard is under consideration with the department. Therefore, such matter is treated as pending.

The facilities providing to the Scheduled Castes categories for establishing the industries in the State of Haryana under the MSME policy.

In its meeting held on 18.10.2023 at Haryana Vidhan Sabha, Chandigarh, the previous Committee was take up the matter of MSME policy under which the facilities are providing to the Scheduled Castes categories for establishing the unit of industries in the State. The Committee observed that the MSME policy of other States are better than our State of Haryana as maximum facilities are providing to the Scheduled Castes categories in this regard.

The previous Committee was disappointed to note that the department failed to supply the requisite information/comments till the presented of 47th report.

The relevant part of the 47th report was supplied to the Industries & Commerce Department vide letter dated 12.03.2024 and a reminder vide letter dated 25.07.2024 was also given to the above quarter concerned for supplying the latest requisite information in details within a week from the receipt of communication in this regard.

The Director General, Micro Small and Medium Enterprises Department has supplied the reply on dated 03.09.2024, which was placed before the Committee in its meeting held on dated 17.02.2025. Such reply is reproduced as under:-

"It is informed that all schemes implemented by this Office are open to Scheduled Castes, Categories for establishing the industries in the State of Haryana however, in some schemes there is special provision for SC/Women led Enterprises. Accordingly, the details of these 02 categories i.e. open scheme and schemes with special provisions for SC Categories for establishing the Industries in the state are as under:

After examine the reply, the Committee noted the contents and decided that the said matter will be take up in the subsequent meetings. Now, the such matter is treated as pending.

Stipend/ post matric scholarship to be disbursing to the students of Scheduled Castes& Backward Classes categories from the year 2020-21till date.

The previous Committee (year 2023-24) was take up the matter of stipend/ Post Matric Scholarship to be disburse to the students from the year 2020-21 till date in its meeting held on dated 11.10.2023 at Haryana Vidhan Sabha, Chandigarh and observed that apart from the cases which are under investigation with the Vigilance Bureau in which scholarship has already been distributed till 31.03.2019, the benefit of stipend/ Post Matric Scholarship to the eligible students of Scheduled Castes & Backward Classes categories are not being disbursing as per the guidelines of the Government properly in true spirit by the concerned departments i.e. Higher Education Department, Technical Education Department, Medical Education & Research Department, Animal Husbandry & Dairying Department, Skill Development & Industrial Training Department and School (Secondary) Education Department.

Out of above six departments two departments i.e. Animal Husbandry & Dairying Department and School (Secondary) Education Department were not supply the reply and the rest of four department i.e. Higher Education Department, Technical Education Department, Medical Education & Research Department and Skill Development & Industrial Training Department have supply their replies which were placed before the previous committee in its meeting held on dated 02.01.2024, but the committee was not satisfied from the contents of the replies and as per the recommendation and observation of the previous committee the quarter concerned were again directed to furnish the correct information. The concerned departments could not furnish their replies till the presented of the 47th report of the committee. After present the 47th report of the committee the recommendations and observations of the previous committee was referred to the quarter concerned vide letter dated 12.03.2024. thereafter, in compliance of that the Social Justice, Empowerment, Welfare of Scheduled Caste & Backward Classes and Antyodaya (SEWA) Department, supply the consolidate replies of Higher Education Department, Technical Education Department, Medical Education & Research Department and Skill Development & Industrial Training Department and Animal Husbandry & Dairying Department vide letter dated 05.04.2024 which was placed before the previous Committee in its meeting held on dated 15.04.2024. The said departments also furnish their replies separately i.e. by the Higher Education Department vide letter dated 09.02.2024 & 04.06.2024 which were placed before the committee in its meeting held on dated 22.04.2024 & 12.08.2024, by the Medical Education & Research Department vide letter dated 12.02.2024 & 09.05.2024 which were placed before the committee in its meeting held on dated 13.05.2024 & 31.05.2024, by the Technical Education Department vide letter dated 18.04.2024 which was placed before the committee in its meeting held on dated 27.05.2024, by the Animal Husbandry & Dairying Department vide letter dated 03.04.2024 which was placed before the committee in its meeting held on dated 27.04.2024 and by the Skill Development & Industrial Training Department vide letter dated 15.04.2024 which was placed before the Committee in its meeting held on dated 27.05.2024, respectively.

After constitution of 15th Assembly, the new Committee was constituted on dated 23.11.2024 and on 2nd December, 2024 the first meeting was conducted by the present committee. The committee discuss the pending matters which were take up by the previous committees with the Director General, of Social Justice, Empowerment, Welfare of Scheduled Caste & Backward Classes and Antyodaya (SEWA) Department and observed that the matter of stipend is required to be take up on priority as the stipend is not disbursing

to the students of SC & BC categories in true spirit. Out of six departments, first of all the Committee decided to conduct the oral examination of the three departments i.e. Higher Education Department, Technical Education Department and Medical Education & Research Department on dated 16.12.2024 and accordingly, the representative of said departments were orally examined in detail and they explained the reasons of pendency of cases of stipend by stating that due to incomplete documents at the part of the students, Aadhar not linked with their accounts and non functioning of the portal which is run by the Higher Education Department, the benefit of stipend is not giving properly to the students. Thereafter, the committee decided to conduct the oral examinations of the Animal Husbandry & Dairying Department and Skill Development & Industrial Training Department on dated 30.12.2024 at 02:45 P.M. & 03:00 P.M. respectively at Haryana Vidhan Sabha, Chandigarh, in respect of pending cases under post Matric Scholarship Scheme for Scheduled Castes and Backward Classes categories. Said oral examination was postponed due to sudden demise of former Prime Minister Dr. Manmohan Singh and the same was conducted on dated 20.01.2025 by the Committee. The representative of both the departments i.e. Animal Husbandry & Dairying Department and Skill Development & Industrial Training Department were orally examined in detail and the committee given the recommendations/observations as under:-

"While conducting the oral examination of Animal Husbandry Department, Haryana, the committee raised various issues in respect of the pendency of post-matric scholarship applications and rejection as well as sent back to the applicants students. The department representatives explained the reason of the pendency and rejections and sent back in detail but the committee was not satisfied with their replies in this regard. The committee directed to submit fresh reply in this regard. The departmental representatives ensured to the committee that fresh reply will be submitted within 10 days positively."

The Committee also decided to conduct the oral examination of all concerned department i.e. Technical Education, Skill Development and Industrial Training, Medical Education & Research alongwith Animal Husbandry & Dairying and Social Justice, Empowerment Welfare of Scheduled Castes and Backward Classes and Antyodaya (SEWA) as well as Higher Education Department, so that the matter may be discussed in detail and the such matter be resolved accordingly."

The unconfirmed proceeding of the above said oral examination was sent to the said departments, thereupon, keeping in view of the recommendations and observations of the committee given in its meeting held on dated 20.01.2025, the Animal Husbandry & Dairying Department furnish the reply vide memo dated 20.02.2025 which was placed before the committee in its meeting held on dated 03.03.2025, the committee minutely examine the contents of the reply and decided that being the replies still awaited from the Skill Development & Industrial Training Department, such matter be keep pending and the same will be again discuss togetherwith the reply of said department in the subsequent meetings.

At present the Welfare of SCBC Department is only providing budget to these Departments and implementation part of the scholarship is being done by the above-said Departments. To fill up the vacancies of backlog of the Scheduled Castes, Scheduled Tribes and other Backward Classes Categories in the Central Higher Education Institutions/Universities etc.

The previous Committee constituted for the year 2021-22 & 2022-23 were take up the matter of vacancies of backlog of the Scheduled Castes, Scheduled Tribes and other Backward Classes Categories in the Central Higher Education Institutions/Universities in its meeting held on dated 19.08.2021. Upon the recommendation and observation of the said previous Committees, the replies/information furnished by the Gurugram University, Gurugram, Bhagat Phool Singh Mahila Vishavvidhalya, Khanpur Kalan, Ch. Bansi Lal University, Bhiwani & Dr. B.R. University, Kaithal Universities but the previous committee was not satisfied from the such replies and again asked to the Chief Secretary to Government, Haryana Human Resources-III to direct the quarter concerned to furnish the requisite information but till presented of the 47th report, no reply was received from the quarter concerned.

Now, the said matter was brought to the notice of the present Committee in its meeting held on dated 03.03.2025 and the Committee decided to keep the pending of such matter as the same will be takeup in the subsequent meetings. Therefore, such matter is treated as pending.

Urban Local Bodies Department

(Central/State's share schemes for the Welfare of Scheduled Castes and Backward Classes Category alongwith allotment/ utilization of Budget of Scheduled Castes/Backward Classes Component Plan).

The previous Committee (2022-2023) was take up the matter of the schemes available for the Welfare of the Scheduled Castes & Backward Classes categories, vacancies & backlog available in the direct recruitment and promotional posts, status of Malin-Bastis, facilities to scavengers as well as budget allotted under the component plan of Scheduled Castes/Backward Classes and utilization of the same etc. in its meeting held on dated 25.01.2023 at Haryana Vidhan Sabha, Chandigarh.

Upon the recommendations/observations of the Committee, quarter concerned were asked to furnish the requisite information vide letter dated 5.4.2023, but the previous Committee was disappointed to note that the departments failed to supply the requisite information/comments till the finalization of 47th report.

The copy of the 47th report was supplied to the concerned departments vide letter dated 12.03.2024 for supplying the latest requisite information at the earliest, but till date no any response has been received from the quarters concerned.

Such matter was again discussed by the previous Committee in its meeting held on 08.07.2024 and upon the recommendations/observations of the previous Committee, the Additional Chief Secretary to Government Haryana, Urban Local Bodies Department furnish the information/reply vide letter dated 05.04.2023, in respect of vacancies, backlog in direct recruitment and promotional posts, status of malin bastis, facilities to scavengers as well as utilization of the budget of component plan of SC categories. The previous Committee was examined the such replies in its meeting held on dated 19.07.2023 and the Committee was not satisfied therewith. The departments were conveyed vide letter dated 12.03.2024 in this regard with the request to supply the information as per recommendations/observations of the Committee but the department neither submit any reply in this regard, nor made any correspondence so far.

The previous Committee again discuss the matter in its meeting held on dated 08.07.2024 and the Committee was surprised to see that inspite of the making the request made vide letter dated 12.03.2024 the department neither took the matter seriously, nor provided the requisite information to the Committee so far. The Committee was took a serious note upon the non performance of the department and was recommended that the information in respect of representation to the candidate of SC category in recruitment, promotion, merger either in department or in Nigam as well as appointment on contract basis, through HKRN & outsources and roaster of seniority etc. be provided to the Committee within a week so that the department may be orally examined thereupon, on dated 22.07.2024. The previous Committee directed to the Officer of the Committee to convey the recommendations/observations of Committee to the quarter concerned to supply the requisite information well in time. Accordingly, a notice of meeting to conduct the oral examination of the guarter concerned was issued on dated 10.07.2024, thereafter, in reference to that notice of meeting, Commissioner & Secretary to Government, Haryana, Urban Local Bodies Department requested vide DO letter dated 19.07.2024 to postponed the said oral examination for next 30 days so that the department can submit the complete report/information. Such request was placed before the Committee in its meeting held on dated 22.07.2024 and the Committee acceded his request and postpone his oral examination.

On further non supply of the requisite information by the said department, a reminder dated 10.12.2024 was also written with the request to supply the latest requisite information in details within a week from the receipt of communication in this regard.

The department is fail to supply the requisite information to the Committee and such matter was brought to the notice of the committee in its meeting held on dated 24.02.2025. The committee was disappointed on non supply of requisite information by the department and decided to take up the matter in the subsequent meetings.

Representations:

S/Shri Dharambir Parwal & others, All Scheduled Castes & Scheduled Castes Social Organization and Ranjeet Singh Nambardar, Village Choma, Palam Vihar, Gurgaon were submit the representation separately and the same were placed before the previous committee in its meeting held on dated 19.07.2023. The committee examined the contents of representation and observed that the proper representations /reservation to the Scheduled Castes category in the seats of Municipal Corporation, Gurugram is not providing. The Committee took a serious note upon not given the proper representation as per prescribed reservation quota of 20%, to the representatives of Scheduled Castes. Upon the recommendations and observations of the committee, the abovesaid representations were referred to the Chief Secretary to Government, Commissioner & Secretary to Government Haryana and Director, Urban Local Bodies Department, Haryana vide letter dated 24.07.2023 with the request to supply the requisite information but the previous Committee was disappointed to note that the department failed to supply the requisite information/comments till the presented of 47th report.

The relevant part of the 47th report was supplied to the said department vide letter dated 13.03.2024 with the request to submit the reply keeping in view of recommendation and observation of the Committee.

The Director, Urban Local Bodies Department furnish the reply vide letter dated 18.05.2024, which was placed before the Committee in its meeting held on dated 17.02.2025. After examine the contents of the reply, the Committee was satisfied and decided to drop the matter.

A Complaint of Shri Manoj Chahal, State President, Roadways SC Employees Sangharsh Samiti of Haryana (Regd. No. 353) Head Office, Rohtak against Shri Vikas Narwal, former General Manager, Haryana State Transport, Rohtak.

Shri Manoj Chahal, State President, Roadways Scheduled Castes Employees Sangharsh Samiti of Haryana (Regd. No. 353) Head Office, Rohtak was submit the representation and the same was placed before the previous committee in its meeting held on dated 19.07.2023. The committee examined the contents of the said allegations leveled by the complaintent against Shri Vikas Narwal, former General Manager, Haryana State Transport, Rohtak in respect of painted and erased the name of Scheduled Castes organization, filed a false case against such organization's State representatives & employees, conspired to spoil the job and insulted the Scheduled Caste organization etc.

Upon the recommendations and observations of the committee, the abovesaid representation was referred to the Principal Secretary to Government, Haryana, Transport Department and General Manager, Haryana Roadways, Rohtak vide letter dated 24.07.2023 with the request to supply the requisite information but the previous Committee was disappointed to note that the department failed to supply the requisite information/comments till the presented of 47th report.

The relevant part of the 47th report was supplied to the said department vide letter dated 13.03.2024 and a reminder on 24.07.2024 was also given to the quarter concerned for supplying the latest requisite information.

The Principal Secretary to Government, Haryana, Transport Department & General Manager, Rohtak supplied their comments/action taken reports vide letters dated 11.10.2024 & 12.11.2024, respectively and the same were placed before the committee in its meeting held on dated 14.12.2024. After examine the contents of the reply, the Committee was satisfied and decided to drop the matter.

A representation of Shri Kuldeep Singh S/o Sh. Jarnail Singh, New Aanaj Mandi, Bazigar Thed Mohalla, Village Mallekan, Distt. Sirsa.

Shri Kuldeep Singh S/o Sh. Jarnail Singh, New Aanaj Mandi, Bazigar Thed Mohalla, Village Mallekan, Distt. Sirsa was submit the representation and the same was placed before the previous committee in its meeting held on dated 02.08.2023. The committee examined the contents of such representation and observed that the atrocities has been caused which is serious in nature and recommended to refer the matter to the Superintendent of Police, Sirsa to obtain the committee, the abovesaid representation was referred to the Superintendent of Police, Sirsa vide letter dated 16.08.2023 with the request to supply the requisite information but the previous Committee was disappointed to note that the department failed to supply the requisite information/comments till the presented of 47th report.

The relevant part of the 47th report was supplied to the Superintendent of Police, Sirsa vide letter dated 14.03.2024 and a reminder on 25.07.2024 was also given with the request to submit the reply keeping in view of recommendation and observation of the Committee.

The Superintendent of Police, Sirsa furnish the comments/action taken report vide letter dated 22.08.2024, which was placed before the Committee in its meeting held on 14.12.2024. After examine the contents of the reply, the Committee was satisfied and decided to drop the matter.

Complaints:

Shri Devender S/o Sh. Dinesh Kumar, #321/2, Firoz Gandhi Colony (No.2) Sector-9, Gurugram and Seema Mehta D/o Late Sh. Sabu Ram Mehta, #1035/29, Gali No. 10, Krishana Colony, Gurugram were submit the representation separately and the same were placed before the previous committee in its meeting held on dated 29.11.2023. The committee examined the contents of the said representations and observed that in such representations there are serious nature of allegations of atrocities caused against the category of Scheduled Castes and to extort the money etc. Therefore, the Committee took a serious note in this regard and recommended to refer the matter to the Commissioner of Police, Gurugram to obtain the comments in this regard within a period of 15 days, positively, from the receipt of communication in this regard. Upon the recommendations and observations of the committee, the abovesaid representations were referred to the Commissioner of Police, Gurugram vide letter dated 30.11.2023 with the request to supply the requisite information but the previous Committee was disappointed to note that the department failed to supply the requisite information/comments till the presented of 47th report.

The relevant part of the 47th report was supplied to the Commissioner of Police, Gurugram vide letter dated 14.03.2024 with the request to submit the reply keeping in view of recommendation and observation of the Committee.

The Commissioner of Police, Gurugram furnish the comments/action taken report vide letter dated 14.05.2024, which was placed before the Committee in its meeting held on 19.06.2024. After examine the contents of the reply, the Committee was satisfied and decided to drop the matter.

Representation of Shri Baljeet Singh, ES Instructor, Government ITI, Gurugram & others.

Shri Baljeet Singh, ES Instructor, Government ITI, Gurugram & others was submit the representation and the same was placed before the previous committee in its meeting held on dated 29.11.2023. The committee examined the contents of the said representation and observed that the Instructors relating to the SC categories are depriving from their promotion upon the post of Principal, resultantly, they are forced to work under the Instructors who are junior to them as they were regularized in the year of 2014 whereas the representationist were regularized in the year of 1995. Upon the recommendations and observations of the committee, the abovesaid representation was referred to the Principal Secretary to Government of Haryana and Director General & Secretary, Skill Development & Industrial Training Department, Haryana vide letter dated 30.11.2023 with the request to supply the requisite information but the previous Committee was disappointed to note that the department failed to supply the requisite information/comments till the presented of 47th report

The relevant part of the 47th report was supplied to the Skill Development & Industrial Training Department vide letter dated 14.03.2024 with the request to submit the reply keeping in view of recommendation and observation of the Committee.

The Director General, Skill Development & Industrial Training Department supplied the comments/reply vide letters dated 04.03.2024 & 12.03.2024 which were placed before the Committee in its meeting held on 17.02.2025. After examine the contents of the replies, the Committee was satisfied and decided to drop the matter.

Appointment/reservation/backlog/strength of employees etc. in direct recruitment as well as in promotion in Urban Local Bodies and Skill Development & Industrial Training Department.

The Previous Committee was take up the matter of backlog of the employees of the Scheduled Castes categories in direct recruitment and promotion relating to the departments of Urban Local Bodies and Skill Development & Industrial Training. The Committee was directed to the officer of the committee to obtained the latest information in respect of appointment/ reservation/backlog/strength of employees etc. in direct recruitment as well as in promotion from the said departments.

The above recommendation and observation of the committee was conveyed to the above said departments vide letter dated 16.01.2024, with the request to submit the information to the committee within 15 days. The departments could not furnish their information till the presented of the 47th report of the committee, thereafter, when the relevant part of the report was sent to the above said departments, then the Skill Development & Industrial Training Directorate Haryana submit the comments vide memo dated 25.04.2024, which are reproduced as under:-

The above said comments were placed before the Committee in its meeting held on dated 13.05.2024. The Committee minutely examine the contents of the reply, The Committee was satisfied with the reply and decided to drop the matter.

Representation of Dr. Manmohan Singh S/o Sh. Mahender Singh, Medical Officer, Civil Hospital, Sector-10, Gurugram.

Dr. Manmohan Singh S/o Sh. Mahender Singh, Medical Officer, Civil Hospital, Sector-10, Gurugram was submit the representation and the same was placed before the previous committee in its meeting held on dated 02.01.2024. The Committee examined the contents of the said representation and observed that the Caste based atrocities are being caused against the representionist. The Committee took a serious note in this regard and directed to refer the matter to the quarter concerned to supply the comments thereupon in this regard. Upon the recommendations and observations of the committee, the abovesaid representation was referred to the Additional Chief Secretary to Government, Haryana and Director General, Health Services, Health Department vide letter dated 03.01.2024 with the request to supply the requisite information but the previous Committee was disappointed to note that the department failed to supply the requisite information/comments till the presented of 47th report.

The relevant part of the 47th report was supplied to the Health Department vide letter dated 15.03.2024 and two reminders dated 24.07.2024 & 16.12.2024 were also written with the request to submit the reply keeping in view of recommendation and observation of the Committee.

The Director General, Health Services, Haryana furnish the reply vide memo dated 04.02.2025, which was placed before the Committee in its meeting held on dated 17.02.2025. After examine the contents of the reply, the Committee was satisfied and decided to drop the matter.

Regarding construction of the roads in the rural areas relating to the Scheduled Castes categories.

The previous Committees (constituted for the year 2021-22 & 2023-24) was take up the matter of utilization of funds of component plan of SC categories by the Public Works (B&R) Department, Agriculture and Farmers Welfare Department, Irrigation & Water Resources Department, Rural Development and Development & Panchayat Department. The previous committee only could conduct the oral examination of three departments i.e. Public Works (B&R) Department, Agriculture and Farmers Welfare Department, Irrigation & Water Resources Department, Agriculture and Farmers Welfare Department, Irrigation & Water Resources Department but due to incomplete information supplied by the departments the committee was not satisfied. Moreover, the department could not furnish their requisite information till the presented of the 47th report of the previous committee.

Being the 15th Assembly constituted and new committee was also constituted on 23.11.2024, the present committee also could not take up the such matter. Now such matter was brought to the kind notice of the Committee in its meeting held on dated 24.02.2025 and after go through with the matter, the Committee observed that its very serious matter and at this stage it could not be take up and the same is required to be placed before the committee which will be constituted for the year 2025-26. Therefore, such matter is treated as pending and the same may be placed before the committee in its subsequent meetings.

Representation of Shri Charnjit Singh and others, Jr. Engineer (Civil) PWD (B&R) Haryana.

Shri Charnjit Singh and others, Jr. Engineer (Civil) PWD (B&R) Haryana, Chandigarh was submit the representation and the same was placed before the previous committee in its meeting held on dated 02.01.2024. The committee examined the contents of the said representation and observed that the proper representation is not being provided in promotion to the employees of the Scheduled Castes categories keeping in view of their castes, resultantly, the Caste based atrocities are also being caused against the representation was referred to the Additional Chief Secretary to Government, Haryana and Engineer-in-Chief, PW(B&R) Department, Haryana vide letter dated 05.01.2024 with the request to supply the requisite information but the previous Committee was disappointed to note that the department failed to supply the requisite information/comments till the presented of 47th report.

The relevant part of the 47th report was supplied to the PW(B&R) Department vide letter dated 15.03.2024 and two reminders dated 24.07.2024 & 16.12.2024 were also written with the request to submit the reply keeping in view of recommendation and observation of the Committee.

The Engineer-in-Chief, Haryana, PWD(B&R) Branch, Chandigarh furnish the reply vide memo dated 06.02.2025, which was placed before the Committee in its meeting held on dated 10.02.2025. After examine the contents of the reply, the Committee was satisfied and decided to drop the matter.

Detail of the homeless people of the SC categories alongwith utilization/nonutilization of budget and pending applications.

The previous Committee was suo-motto take up the matter of homeless peoples belonging to the SC categories in its meeting held on dated 02.01.2024 at Haryana Vidhan Sabha Secretariat, Chandigarh. Upon the recommendation and observation of the Committee inserted in the 47th report, the Director General, Department of Housing For All, Haryana furnish the detailed reply vide letter dated 16.08.2024 alongwith booklet of Mukhya Mantri Gramin Awas Yojana Extension (MMGAY-E). The contents of the reply are reproduced as under:-

"The Council of Ministers in its meetings held on 12.07.2024 and 05.08.2024 has approved a policy of "Mukhya Mantri Shehri Awas Yojana" (MMSAY) for providing affordable housing to the families residing in Urban areas and having family annual income upto 1.80 lakh as verified in Parivar Pehchan Patra (PPP). Under this policy, eligible beneficiaries will be allotted one marla (30 sq.yd.) plots at a cost of 1.00 lakh and supplemented by facility of financial assistance through a combination/convergence of schemes, loans and interest subvention, to enable them to build their Pucca house. As per policy, preference (i.e. 1 st, 2 nd, 3 rd & 4th) in the allotment of plots will be given to Ghumantu Jati, Widow, SCS and Others respectively. In order to ascertain the demand under this policy, an online survey for registration of demand of housing was conducted w.e.f. 13.09.2023 to 19.10.2023. Thereafter, an online booking of plots for the eligible registered applicants was opened In 14 towns namely Charkhi-Dadri, Fatehabad, Jhajjar, Julana, Pinjore, Mahendergarh, Safidon, Sirsa, Gohana, Jagadhrl, Rewari, Palwal, Rohtak, Karnal. w.e.f. 01.02.2024 to 22.02.2024. As such, out of 24.757 registered applicants who booked their plots, 15,250 applicants belonging to Ghumantu Jati, Widow, SCS and Other categories have been allotted one marla plots in these towns. In addition, booking of plots will be opened shortly for the eligible applicants in another 5 towns namely Ambaet Kaithal, Jind, Hisar, Bahadurgarh. A copy of MMSAY is enclosed.

Akin, the Council of Ministers in its meeting held on 05.08.2024 has approved a scheme "Mukhya Mantri Gramin Awaas Yojana-Extension" (MMGAY-E) with an objective of providing housing facility to the needy families residing in rural areas and having family annual income upto Rs. 1.80 lac as verified in Parivar Pehchan Patra. Under the scheme, landless families residing in Mahagram panchayats will be provided plots measuring 50 sq. yd. and 100 Sq. Yd. Plots at the cost of Rs 1000/- to all eligible families residing in other regular panchayats for constructing their pucca house."

Such reply and booklet was placed before the previous Committee in its meeting held on dated 24.02.2025. The committee minutely examine the contents of the reply and scheme and stated that such scheme is very valuable for the poor people and decided to keep pending at this stage as the same will be takeup in the subsequent meetings. Now, such matter is treated as pending.

Facilities providing to the colonies which have been constructed under the Mahatma Gandhi Gramin Basti Yojana.

The previous Committee was suo moto takeup the matter of 100-100 Sq. Yard plots allotted to the BPL families in its meeting held on dated 02.01.2024. Upon the recommendations and observations of the previous Committee, the concerned departments i.e. Additional Chief Secretary to Government, Haryana, Development & Panchayat Department, Director and Special Secretary, Rural Development Department and all the Deputy Commissioners to Haryana were requested vide letter dated 05.01.2024 to furnish their replies within 15 days from the receipt of communication in this regard but the previous Committee was disappointed to note that till the presented of the 47th report, the above concerned departments have not furnish the requisite information/reply.

The relevant part of the 47th report was supplied to the Rural Development Department vide letter dated 18.03.2024 with the request to submit the reply keeping in view of recommendation and observation of the previous Committee.

The previous Committee also discussed the matter regarding providing basic facilities to the BPL colonies constructed under the Mahatma Gandhi Gramin Basti Yojana in its meeting held on dated 27.04.2024. The Previous Committee observed that the basic facilities i.e. electricity, drinking water, construction of streets, registration of plots/houses and possession of the property to the concerned in the colonies constructed under the Mahatma Gandhi Gramin Basti Yojana are not providing properly and recommendations and observations of the previous committee are not taking seriously by the departments as the maximum works are still pending. The previous Committee directed the Officer of the Committee to written a letters to the Commissioner & Secretary of concerned departments and all the Deputy Commissioners to furnish the district wise & colonies wise detailed report within a period of 15 days, positively, about the relevant works which have been completed and which are still pending and submit the same to the Committee in its subsequent meeting so that further action may be taken accordingly.

Upon the recommendations and observations of the previous committee a letter dated 06.05.2024 was written to the Rural Development Department and All Deputy Commissioner, Haryana with the request to submit the replies of the facilities to the BPL colonies i.e. electricity, drinking water, construction of streets, registrations of plots/houses and possession of the property to the concerned beneficiaries etc. in the colonies constructed under the Mahatma Gandhi Gramin Basti Yojana. Thereafter, another letter dated 26.07.2024 to the Energy Department, Public Health Engineering Department and PWD (B&R) Department was written to supply the requisite information as asked through letter dated 06.05.2024 as well as a reminder dated 10.12.2024 was also given to all the quarter concerned to furnish the requisite information as desired by the previous committee. The term of the previous Committee was end on dated 12.09.2024, upon discussion of 14th Assembly.

Upon constitution of the 15th Assembly, the present committee was constituted on dated 23.11.2024 and the Committee in its meeting held on dated 08.07.2024, when suo motto discuss the matter of lack of basic facilities in such BPL colonies, the detailed reply in this regard which was already furnished by the Director, Rural Development Department upon the recommendation of the previous Committee vide memo dated 21.05.2024, was placed before the Committee in such meeting. The committee go through with all the contents of the such information and observed that in maximum number of colonies, the basic facilities as stated above have not been provided so far. Therefore, the committee
was not satisfied with the above said reply and decided to the concerned department will be orally examined in one of its subsequent meetings which will be fixed later on. Thereafter, the Committee again discuss the said matter in detail in its meeting held on dated 15.01.2025. After discussion, the committee given the recommendation/observation as under:-

The Committee discussed about the matter of colonies constructed under the Mahatma Gandhi Basti Yojana. The Committee observed that the basic facilities i.e. electricity, drinking water, roads/streets are not providing properly in these colonies as well as the possession of number of plots have not been given to the allottees. The Committee also observed that the allotted plots have not been registered in favour of the allottees so far. Upon the said observation of the Committee, the detailed reply of the Director, Rural Development Department vide memo dated 21.05.2024 furnished upon the recommendation of the previous Committee, wherein the information in respect of the facilities of the possession of the plots, registration of the plots, electricity, drinking water, unpaved streets and ways of colonies connected with the roads were available, was placed before the Committee. The Committee go through with all the contents of the such information and observed that in maximum number of colonies the basic facilities as stated above have not been provided so far.

The Committee took a serious note in this regard and decided to discuss the matter with the concerned departments i.e Rural Development, Development & Panchayats, Energy Department, Public Health Engineering Department, PW (B&R) Department and Revenue & Disaster Management Department to ascertain the factual and latest position in respect of the above-mentioned facilities providing in the colonies in question. The Committee also decided to conduct the oral examination of the above said departments on dated 27.01.2025 wherein the said matter will be discussed at the same time with the concerned officers. The Committee further decided that after conducting the such oral examination, the Committee will conduct the meetings at District Head Quarters levels as well as may also conduct the spot visit in the colonies while conducting the meeting at District Head Quarters.

The Committee also directed the officer of the Committee to ask the concerned departments by providing the recommendations/observations of the Committee, to appear before the Committee on the said scheduled. The Committee also directed that the concerned departments be also asked to provide the detailed and latest relevant information up to 23.01.2025 so that the Committee may examine the same before discuss with the departments".

As per above recommendations/observations of the Committee, the notice of meeting was served to the quarters concerned to appear before the committee for their oral examination on dated 27.01.2025 upon the matter in question. Accordingly, the oral examination of the concerned departmental representative was conducted as per schedule and after the detailed proceeding of the oral examination, the committee given the recommendations/observations as under:-

"During the oral examination of the Departmental representatives the Committee raised the issues in respect of the facilities to be provided to the BPL Colonies constructed under Mahatma Gandhi Gramin Basti Yojana. The Departmental representatives tried to explain each and everything to the Committee but the Committee was not satisfied with their reply as the facts of their replies were contradictory to each other. The Commissioner & Secretary to Government Haryana, Rural Development Department stated that due to lack of budget such kind of facilities could not be provided to these colonies in true spirit as required to these colonies and they have demanded Rs.100 crore budget for the next Financial Year and in case if the budget will be given to the Rural Development Department. the facilities will be provided accordingly. The representatives of the department requested to the Committee to give two months's time to submit the fresh reply. The representatives of departments stated that the task force will be constituted under the Chairmanship of all the Deputy Commissioners and the fresh data will be collected and after consolidating the same the same will be placed before the Committee within two months so that the same may be examined/discussed in the Committee in its subsequent meetings. The Committee acceded the requested and gave time of two months to collect the data and place it before the Committee and also asked them to give priority in providing these facilities to these colonies which have completed the construction work of 25% and above. The Rural Development Department ensured to the Committee that the colonies will be bifurcated as per their status and the colonies which have been completed the work of more than 25%. priority of providing facility will be given to them.

The Committee further asked the Departments to submit the replies within stipulated period and also stated that the Committee will spot visits at the District Head Quarters as well as at the concerned colonies in the subsequent meetings".

As on the request of the representative of the departments, the committee given two month time to furnish the reply i.e. the departments have to furnish the reply up to dated 27.03.2025. Being the budget session is commencing from 07.03.2025, the said matter now will be takeup by the Committee which may be constituted for the year 2025-26.

Representation of Shri Hari Singh, Pardhan, Kurukshetra University, Kurukshetra Scheduled Caste Employees Association.

A representation of Shri Hari Singh, Pardhan, Kurukshetra University, Kurukshetra Scheduled Caste Employees Association was placed before the Committee, in its meeting held on dated 08.07.2024 at 4.00 P.M at Haryana Vidhan Sabha. After examine the said representation, the Committee observed that the proper representation is not providing in promotion to the employees of the Scheduled Caste categories. The Committee took a serious note in this regard and recommended to refer such representation to the Vice-Chancellor, Kurukshetra University, Kurukshetra as well as Chief Secretary to Government, Haryana to examine the matter thoroughly and submit the comments/reply within 15 days from the receipt of the communication in this regard.

Upon the above recommendation of the committee, the representation was referred to the above mentioned quarter concerned vide letter dated 11.07.2024, with the request to submit the comments/information to the committee within 15 days. In response to such letter the Registrar Kurukshetra University, Kurukshetra has supplied the comments on dated 19.09.2024, which was placed before the Committee in its meeting held on 14.12.2024. The Committee minutely examine the contents of the reply, The Committee was satisfied with the reply and decided to drop the matter.

Recommendations and observations of the Committee upon the matter of misbehave/ atrocity caused with Shri Ishwar Singh, MLA.

The member namely Sh. Cheeranjiv Rao and Sh. Shispal Singh of the pervious committee raised the issue relating to Sh. Ishwar Singh the then MLA now Ex-MLA by stating that some people of village Bhatia, District Kaithal have misbehaved with the respectable Member and also slapped him by a lady, besides it, number of persons of the same village i.e. Bhatia surrounded him and compel to sit on the ground. They have also alleged that Shri Ishwar Singh, MLA is belonging to SC category due to that such kind of misbehave has been caused with him which amounts to caused atrocity with the Hon'ble Member. The committee was took the cognizance seriously thereupon and recommended to refer the matter to the Director General of Police, Superintendent of Police and Deputy Commissioner, Kaithal with the direction to submit the action taken report upon the matter in question within three days from the receipt of communication.

Upon the recommendation and observation of the previous Committee, the quarters the concerned submit the replies in detail as well as Deputy Commissioner and Superintendent of Police of district Kaithal were orally examined by the previous Committee in its meeting held on dated 26.07.2023. Shri Ishwar Singh, Ex. MLA was verbally asked to the Committee that the matter has been sorted out with the villagers of village Bhatia and also request to the Committee to drop the matter but the previous Committee was not satisfied with the replies of the quarter concerned. Moreover, the complete proceeding of the replies and of the oral examination have been inserted in the 47th report presented by the previous committee.

Now such pending matter was brought to the kind notice of the committee in its meeting held on dated 24.02.2025 and the committee was of the view that when the effected Ex. Member is satisfied and don't want to take any action against the culprits, then no need to proceed the matter further, therefore, the committee decided to drop the matter.

The matters of atrocities i.e. crime/conviction/ acquittal/pending cases in the Hon'ble Court caused against the Scheduled Castes categories.

In its meeting held on 13.05.2024 at Haryana Vidhan Sabha, Chandigarh, the Committee again take up the matter of atrocity and observed that the copy of the FIR registered under the Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act, 1989 are not providing to the District Welfare Officer's concerned in time, resultantly, the victims are depriving from the assistance of amount of compensation. The members of the Committee also stated that some victims in their constituencies are complaining them regularly upon not granting the compensation in the matter of atrocities, therefore, the Committee observed that the amount of compensation in the matter of atrocities is not disbursing in time to the victims.

In respect of rate of conviction in the cases of atrocities, the Committee also observed that inspite of recommendations of the previous Committee and assurance of the Department of Prosecution, the rate of conviction in the matter of atrocities is not improving as in the maximum number of cases the accused are acquitting.

The Committee took a serious note in respect of the above matters and directed to the officers of the Committee to obtain the status report from all the Commissioner of Police/Superintendent of Police's posted at district headquarter, District Welfare Officer's and District Attorney's within 15 days by providing the prescribed proformas and placed the same before the Committee as and when received the reports.

Upon the above recommendation and observation of the committee, request was made to the Additional Chief Secretary to Govt. Haryana, Home Department, the Commissioner and Secretary to Govt. Haryana, Social Justice, Empowerment, Welfare of Scheduled Caste and Backward Classes and Antyodaya (SEWA) Department and the Director Prosecution Department Haryana vide letter dated 17.05.2024 to supply the requisite information as per enclosed proformas. In reference to that the replies/information in respect of providing the copies of FIR to the DWO, rate of conviction and compensation to the victims etc. from the various district headquarters i.e. Superintendent of Police, District Attorney and District Welfare Officer, respectively, have been received but the number of district headquarters have not furnish their replies/information so far, meaning thereby, the complete information has not been provided by the department of Prosecution to the committee so far. Now such matter was brought to the kind notice of the Committee in its meeting held on dated 24.02.2024. After go through the matter, the Committee took a serious note thereupon and observed that being shortage of time such matter can not be considered at this stage and the same may be take up by the Committee which will be constituted for the year 2025-26, therefore, such matter be treated as pending.

हरियाणा विधान सभा कि अनुसूचित जातियों, जन जातियों तथा पिछडे. वर्गों के कल्याण सम्बन्धी समिति द्वारा किए गए केंद्र शासित प्रदेश, जम्मू एवं कश्मीर, श्रीनगर के अध्य्यन दौरे पर संक्षिप्त रिपोर्ट।

हरियाणा विधान सभा कि अनुसूचित जातियों, जन जातियों तथा पिछडे. वर्गों के कल्याण सम्बन्धी समिति ने दिनांक 23–06–2024 से 29–06–2024 तक केंद्र शासित प्रदेश, जम्मू एवं कश्मीर, श्रीनगर का अध्य्यन दौरा किया जिस दौरान विभिन्न स्थानों पर बैठकें की। तय कार्यक्रम के अनुसार समिति जम्मू एवं कश्मीर विधान सभा सचिवालय, श्रीनगर के समिति कक्ष में समाज कल्याण विभाग, जम्मू एवं कश्मीर के साथ बैठक करने के लिए दिनांक 26–06–2024 को प्रातः 11:00 बजे पहुंची जहां पर श्री बिलाल अहमद, उप–सचिव, जम्मू एवं कश्मीर विधान सभा, मो. अकबर वानी, निदेशक, श्री फयाज अहमद, जू अनुभाग अधिकारी, श्री मुजफ्फर अहमद, समाज कल्याण विभाग, जम्मू एवं कश्मीर व अन्य उपस्थित अधिकारियों ने आगंतुक समिति के सभापति, सदस्यों व स्टाफ का गर्मजाशी से स्वागत किया।

समाज कल्याण विभाग, जम्मू एवं कश्मीर के साथ समिति की बैठक ।

मोहम्मद अकबर वानी, निदेशक ने विभाग की तरफ से उपस्थित अधिकरीयों का परिचय करवाया तत्पश्चात समिति के सभापति ने अपना, समिति के सदस्यों, अधिकारी व कर्मचारियों का परिचय करवाया । सचिव, जम्मू एवं कश्मीर, विधान सभा द्वारा आगंतुक समिति को बैठक करने के लिए समय देने, स्वागत करने तथा बाकी इन्तजाम करने के लिए माननीय सभापति महोदय ने समिति की ओर से उनका आभार व्यक्त किया ।

माननीय सभापति महोदय ने समिति की कार्यप्रणाली पर चर्चा करते हुए अधिकारियों को बताया कि हरियाणा विधान सभा में 12 समितियां है जिनमें से अनुसूचित जातियों, जन जातियों तथा पिछडे. वर्गों के कल्याण सम्बन्धी समिति भी एक महत्वपूर्ण समिति है जो समय—समय पर अपने सभी मैटर्स को विभाग के अतिरिक्त मुख्य सचिव, सचिव व निदेशकों से तथा सरकार से अपने प्रस्तावित एजेंडा पर विचार—विमर्श करती है और उस पर विभागों को रिक्मंडेशन देती है । उन्होंने बताया कि हमारी समिति केन्द्रीय सरकार और राज्य सरकार की जो अनुसूचित जातियों, जन जातियों तथा पिछड़े वर्गों के कल्याण सम्बन्धी स्कीम्ज हैं उनकी कार्यान्वयन और इम्पलीमेंटेशन के लिए काम करती है और जहां यह लगता है कि यहां सुधार की आवश्यकता है उसके लिए समिति विभाग को अपनी रिक्मंडेशन भी देती है । उन्होंने यह भी कहा कि हमारी समिति केन्द्र शासित प्रदेश के अलावा बाकी सभी राज्यों में जाकर एक अध्ययन दौरा करती है और उस अध्ययन दौरे में हम यह जानने की कोशिश करते हैं कि हम उस राज्य से क्या अच्छा लेकर जाएं जिससे दूसरे राज्यों की प्लानिंग व योजनाएं हमारे हरियाणा प्रदेश की अनुसूचित जातियों, जनजातियों तथा पिछड़े वर्गों का कल्याण के लिए काम आ सकें। माननीय सभापति ने उपस्थित अधिकारियों को बताया कि हमारी समिति की तरफ से आपको एक रिक्मंडेशन है कि हरियाणा प्रदेश की अनुसूचित जातियों, जनजातियों तथा पिछड़े वर्गों के कल्याण संबंधी समिति की जो अच्छी योजनाएं है उनको आप भी यहाँ पर इम्प्लीमेंट करें ।

समाज कल्याण विभाग के अधिकारियों ने बताया कि केंद्र शासित प्रदेश, जम्मू एवं कश्मीर में कि यह विभाग वर्ष 1960 में अस्तित्व में आया। यह विभाग समाज के कमजोर वर्गों जैसे वृद्ध व्यक्तियों, संकट ग्रस्त महिलाओ, विधवाओं, उग्रवाद पीड़ितों, अनाथों, शारीरिक रूप से अक्षम बच्चों, कुपोषित बच्चों, अनुसूचित जातियों, जनजातियों व पिछड़े वर्गों और समाज के अन्य आर्थिक रूप से कमजोर वर्गों के सामाजिक—आर्थिक उत्थान को सुनिश्चित करने में महतवपूर्ण भूमिका निभा रहा है। यह विभाग महिला बाल विकास विभाग, सामाजिक न्याय और आधिकारिता, सामाजिक सुरक्षा, जनजातीय विकास और एससी / एसटी और ओबीसी छात्रों के शैक्षणिक उत्थान के क्षेत्रों में केंद्र और राज्य सरकार की योजनायों का प्रबंधन करता है। यह छात्रवृति, छात्रावास सुविधाओं, परीक्षा शुल्क की प्रतिपूर्ति आदि के माध्यम से लक्षित समूहों को सीधा लाभ प्रदान करता है।

विभाग के अधिकारियों ने आगंतुक समिति को जम्मू एवं कश्मीर राज्य व लद्दाख की भोगोलिक संरचना के बारे में अवगत करवाया तथा बताया कि जम्मू एवं कश्मीर तथा लद्दाख के केन्द्र शासित प्रदेशों में पुनगर्ठित करने के लिए जम्मू एवं कश्मीर पुनर्गठन अधिनियम पारित किया गया था, मार्च, 2020 से पहले जम्मू एवं कश्मीर के केंद्र शासित प्रदेश के परिसीमन के लिए परिसीमन आयोग का गठन किया गया था । जम्मू एवं कश्मीर विधान सभा चुनाव में 121 परिसीमन रिपोर्ट में जम्मू संभाग में अतिरिक्त 06 सीटें और कश्मीर संभाग में 01 सीट जोड़ी गई थी। परिसीमन के बाद विधान सभा में कुल सीटें बढकर 114 हो गई थी जिनमें से 24 सीटें उन क्षेत्रों के लिए नामित है जो पाकिस्तान शासित कश्मीर के अंतर्गत आती है। शेष 90 सीटों में से 43 सीटें जम्मू संभाग में और 47 सीटें कश्मीर संभाग में है उसके बाद संसद ने जम्मू एवं कश्मीर पुर्नगठन (संशोधन) विधेयक, 2023 पारित किया जिसमें अनुसूचित जाति के लिए 07 सीटें और अनुसूचित जनजाति के लिए 09 सीटें निर्धारित की गई है। जम्मू एवं कश्मीर पुनर्गठन अधिनयम, 2019 ने सदन में महिलाओं का पर्याप्त प्रतिनिधितव नहीं होने पर उपराज्यपाल द्वारा विधान सभा में 02 सदस्यों के नामांकन का प्रावधान किया। वर्ष 2023 में अधिनयम में संशोधन के बाद उप—राज्यपाल कश्मीर प्रवासी परिवारों में 02 प्रतिनिधियों में (एक सीट महिला के लिए आरक्षित) और एक सदस्य को पाकिस्तान प्रशासित कश्मीर के प्रवासियों का प्रतिनिधित्व करने के लिए नामांकित कर सकते है।

केन्द्र शासित प्रदेश, जम्मू एवं कश्मीर में अनुसूचित जातियों, जनजातियों तथा अन्य पिछड़े वर्गों के कल्याण के लिए चल रही योजनाएं जैसे कि शिक्षा के लिए प्री—मेट्रिक स्कालरशिप, पोस्ट—मेट्रिक स्कालरशिप, आर्थिक रूप से पिछड़े वर्गों के लिए डॉक्टर अंबेडकर पोस्ट—मेट्रिक स्कालरशिप, घुमंतू एवं खानाबदोश जनजातियों के लिए डॉक्टर अंबेडकर प्री—मेट्रिकध्पोस्ट मेट्रिक स्कालरशिप आदि दी जाती है तथा अनुसूचित जातियों व जनजातियों के पांचवी कक्षा तक के बच्चों के लिए जो पहाड़ो पर रहते है और स्कूल तक नहीं आ सकते उनके लिए सरकार ने मोबाइल स्कूल खोले हुए है । जब बच्चें उच्च कक्षा में जाते है तो उन्हें होस्टल में शिफ्ट कर देते है व खाने पीने की सुविधाएँ भी मुफ्त में देते है । शिक्षा में ज्यादा जागरूकता न होने के कारण ज्यादातर होस्टल खाली रहते है ।

अधिकारीगणों ने बताया कि हमारे यहाँ जम्मू एवं कश्मीर में 22 लाख के करीब जनसँख्या है । जिसमें अनुसूचित जाति की जनसंख्या 09 लाख के करीब है और अनुसूचित जनजाति की जनसंख्या 13 लाख के करीब है । यहाँ पर नौकरियों में 07 प्रतिशत अनुसूचित जाति के लिए और 10 प्रतिशत अनुसूचित जनजाति के लिए आरक्षित है । अनुसूचित जातियों, जनजातियों तथा अन्य पिछड़े वर्गों के उत्थान के लिए अलग से वार्षिक बजट का भी प्रावधान किया जाता है ।

माननीय समिति ने केंद्र शासित प्रदेश, जम्मू एवं कश्मीर के समाज कल्याण विभाग के अधिकारियों द्वारा बताई गई केंद्र शासित प्रदेश, जम्मू एवं कश्मीर में अनुसूचित जातियों, जनजातियों एवं पिछड़े वर्गों के कल्याण के लिए चल रहीं स्कीमों का हरियाणा प्रदेश में चल रही कल्याणकारी स्कीमों के साथ तुलनात्मक अध्ययन किया।

समिति ने अधिकारीगणों को बताया कि हरियाणा प्रदेश में चल रही विभिन्न प्रकार की कल्याणकारी योजनाओं जैसे कि मुख्यमंत्री विवाह शगुन योजना, बुढ़ापा पेंशन योजना, कृषि यंत्रों पर सब्सिडी, एट्रोसिटी के केसिज में पीड़ितों को कम्पनसेशन, प्रधानमंत्री आवास नवीनीकरण योजना, छात्रवृति योजना इत्यादि के बारे में विस्तार से अवगत करवाया और सुझाव दिया कि इन योजनाओं को भी यहां पर लागू करवाना चाहिए ताकि जरूरतमंद लोगों को इसका लाभ मिल सके और वह अपने जीवन स्तर को ऊपर उठा सके। माननीय समिति ने उक्त समाज कल्याण के अधिकारियों को हरियाणा प्रदेश की कल्याणकारी योजनाओं से संबंधित एक बुकलैट भी दी तथा सुझाव दिया कि इन योजनाओं का गहराई से अध्ययन करके और विभाग की तरफ से एक केस बनाकर माननीय उप राज्यपाल महोदय के सम्मुख भेजें ताकि हरियाणा प्रदेश जैसी योजनाएं आपके यहां भी लागू हो सकें और गरीब लोगों का उत्थान हो सके। समाज कल्याण के अधिकारियों ने भी माननीय समिति के सुझावों व हरियाणा प्रदेश की योजनाओं की सराहना की तथा समिति को आश्वस्त किया की समिति के दिए गए सुझावों को तथा हरियाणा प्रदेश की योजनाओं को सराहना की तथा समिति को आश्वस्त किया की समिति के दिए गए सुझावों को तथा हरियाणा प्रदेश की योजनाओं को सराहना उच्च अधिकारीगणों के सम्मुख रखा जाएगा तथा माननीय उप राज्यपाल महोदय से स्वीकृति के उपरान्त गरीब लोगों को हरियाणा प्रदेश की योजनाओं के अनुसार लाभ दिया जाएगा ।

हरियाणा विधान सभा कि अनुसूचित जातियों, जन जातियों तथा पिछडे. वर्गों के कल्याण सम्बन्धी समिति ने दिनांक 09.01.2025 से 12.01.2025 तक गोवा राज्य का अध्य्यन दौरा किया जिस दौरान विभिन्न स्थानों पर बैठकें की। समिति गोवा राज्य विधान सभा सचिवालय, पणजी के समिति कक्ष में विधान सभा के प्रशासनिक अधिकारियों के साथ बैठक करने के लिए दिनांक 10.01.2025 को दोपहर बाद 03:00 बजे पहुंची जहां पर सचिवालय के अधिकारियों ने आगंतुक समिति के सभापति, सदस्यों व स्टाफ का गर्मजाशी से स्वागत किया।

गोवा विधान सभा की लाईब्रेरी व हाउस का दौरा ।

सर्वप्रथम समिति ने गोवा विधान सभा की लाईब्रेरी का दौरा किया जिसमे उपस्थित श्री संजय सिंह, लाईब्रेरियन ने समिति को जानकारी दी कि लाईब्रेरी में लगभग 22000 विभिन्न विषयों से सम्बंधित किताबें है, सन 1914 से लेकर सन 2000 तक सभी ऑल इंडिया रिपोर्टर (।ए) उपलब्ध है तथा यहाँ पर रिसर्चर और लॉ स्टूडेंट्स विजिट करते रहते है जिनको हम फ्री वाई–फाई और किताबें उपबल्ध करवाते है। उन्होंने बताया कि विधान सभा के सदस्यों और स्टाफ को भी यहाँ सभी प्रकार की सुविधाए मिलती है। इसके बाद समिति ने विधान सभा के हाउस का दौरा किया।

गोवा विधान सभा के अधिकारियों के साथ समिति की बैठक।

श्री मोहन गांवकर, अवर सचिव, गोवा ने विधान सभा सचिवालय की तरफ से उपस्थित अधिकारियों का परिचय करवाया तथा समिति के अधिकारी ने अपना व समिति के माननीय सदस्यों व कर्मचारियों का परिचय करवाया । मैंने समिति की ओर से माननीय अध्यक्ष व सचिव महोदय, गोवा विधान सभा के द्वारा आगंतुक समिति को बैठक करने के लिए समय देने, स्वागत करने तथा बाकी इन्तजाम करने के लिए उनका आभार व्यक्त किया । तत्पश्चात, अधिकारयों द्वारा समिति को यह बताया कि जहा तक माननीय अध्यक्ष महोदय, विधान सभा के साथ समिति की बैठक का विषय है उनके साथ समिति की बैठक होने संभव नहीं है क्योंकि अध्यक्ष महोदय आज अपरिहार्य कार्यों के कारण व्यस्त है, इसके अलावा अधिकारयों द्वारा समिति को यह भी सूचित किया गया कि विधान सभा का सत्र निकट है प्रश्नों के ड्रा के लिए सांय 04:00 बजे का समय पहले से ही रखा हुआ है। जिसके कारण सचिव महोदय भी व्यस्त है इसलिए उनके साथ भी माननीय समिति की बैठक होना संभव नहीं है। अवर सचिव, गोवा विधान सभा ने कहा कि जहाँ तक समिति की बैठक का सवाल है तो मैं आपके समक्ष उपस्थित हूँ। हमारी विधान सभा की सभी समितियों की वर्किंग और राज्य से रिलेटेड जो भी जानकारी आंगतुक समिति को चाहिए हम प्रत्येक विषय पर वांछित जानकारी देने के लिए पुरी तरह से तत्पर है।

समिति ने अपनी कार्यप्रणाली पर चर्चा करते हुए गोवा विधान सभा सचिवालय के अधिकारियों को बताया कि हरियाणा विधान सभा में 13 समितियां है जिनमें से अनुसूचित जातियों, जन जातियों तथा पिछडे. वर्गों के कल्याण सम्बन्धी समिति भी एक महत्वपूर्ण समिति है जो समय—समय पर अपने सभी मामलों को विभागों के अतिरिक्त मुख्य सचिवो, प्रधान सचिवों व निदेशकों तथा सरकार से अपने प्रस्तावित एजेंडा पर विचार—विमर्श करती है और उस पर विभागों को रिक्मंडेशन देती है । उन्होंने बताया कि हमारी समिति केन्द्रीय सरकार और राज्य सरकार की जो अनुसूचित जातियों, जन जातियों तथा पिछडे. वर्गों के कल्याण सम्बन्धी स्कीम्ज हैं उनकी कार्यान्वयन और इम्पलीमैंटेशन के लिए काम करती है और जहां यह लगता है कि यहां सुधार की आवश्यकता है उसके लिए समिति विभागों को अपनी रिक्मंडेशन भी देती है ।

मैंने बताया कि हमारे प्रदेश में अनुसूचित जाति / विमुक्त जाति / टपरीवास जाति में जिस परिवार की आमदनी 1 लाख 80 हजार रूपये वार्षिक से कम हैं, उनको मुख्यमंत्री विवाह शगुन योजना के अन्तर्गत 71 हजार रुपये तक की सहायता प्रदान की जाती है, डॉ. बी.आर. अम्बेडकर आवास नवीनीकरण योजना के तहत मकान मरम्मत हेतु 80,000 रुपये तक की सहायता का प्रावधान है, अनुसुचित जाति एवं पिछड़े वर्ग से संबंधित संस्थाओं एवं सोसायटीज को भी 2 लाख रुपये तक की वित्तीय सहायता प्रदान करने का प्रावधान भी है । इसी प्रकार से अनुसूचित जाति व पिछड़ा वर्ग के उम्मीदवारों को उच्च प्रतिस्पर्धीध्प्रवेश परीक्षा की तैयारी के लिए 2–50 लाख रूपये तक की वार्षिक वित्तीय सहायता प्रदान की जाती है, एट्रोसिटीज केसिज में 85,000 रुपये से लेकर 8–25 लाख रूपये तक की राशि अनुसुचित जाति के व्यक्तियों को सहायता के रूप में देने का प्रावधान है । इसी तरह से मुख्यमंत्री सामाजिक समरसता अन्तर्जातीय विवाह शगुन योजना में 2–50 लाख रुपये तक की सहायता राशि प्रदान की जाती है तथा इसके अलावा अनुसूचित जाति व पिछडा वर्ग के छात्रों हेतू पोस्ट मैट्रिक छात्रवृत्ति व प्री–मैट्रिक छात्रवृति और सफाई तथा जान जोखिम वाले व्यवसायों में लगें लोगो के बच्चो के लिए प्री–मैट्रिक छात्रवृति जैसी बहुत सारी स्कीमें हरियाणा सरकार द्वारा गरीब लोगों के कल्याण के लिए चलाई हुई हैं। माननीय सभापति ने यह भी कहा कि हमारी समिति केन्द्र शासित प्रदेश के अलावा बाकी सभी राज्यों में जाकर एक अध्ययन दौरा करती है और उस अध्ययन दौरे में हम यह जानने की कोशिश करते हैं कि हम उस राज्य से क्या अच्छा लेकर जाएं जिससे दूसरे राज्यों की प्लानिंग व योजनाएं हमारे हरियाणा प्रदेश की अनुसुचित जातियों, जनजातियों तथा पिछडे वर्गों का कल्याण के लिए काम आ सकें इसलिए आपसे निवेदन हैं कि आप भी अपने राज्य की कल्याणकारी योजनाओं के बारे में समिति को अवगत कराएं ताकि कोई अच्छी योजना का हमारा राज्य भी लाभ ले सकें और हमारी समिति की तरफ से आपको एक सुझाव है कि हरियाणा प्रदेश की अनुसूचित जातियों, जनजातियों तथा पिछडे वर्गों के कल्याण संबंधी समिति की जो अच्छी योजनाएं है उनको आप भी यहाँ पर इम्प्लीमेंट करें ।

गोवा विधान सभा सचिवालय के अधिकारियों द्वारा समिति को यह बताया गया कि हमारी विधान सभा में इस प्रकार की कोई सिस्टर समिति नहीं है और न ही कोई सब्जेक्ट समिति है लेकिन हमारे यहाँ पर वेलफेयर ऑफ शिड्यूल कास्ट एंड शिड्यूल ट्राईब्स और बैकवर्ड क्लासिज के उत्थान के लिए एक गोवा कमीशन शिड्यूल कास्ट एंड शिड्यूल ट्राईब्स है । इसके अलावा हमारे यहाँ पर एक डायरक्टोरेट ऑफ ट्राइबल वेलफेयर भी बना हुआ है जो कि 2003 में अलग–अलग हो गए थे ।

श्री मोहन गांवकर, अवर सचिव ने माननीय समिति को बताया कि गोवा राज्य की विधानसभा में कुल 40 सीटें है जिनमें से 23 सीटें नॉर्थ गोवा के अन्तर्गत और 17 सीटें साउथ गोवा के अन्तर्गत आती है तथा हमारे यहां पर विधान सभा में एस.टी. के लिए एम.एल.ए. की एक सीट रिजर्व है । लोकसभा की दो सीटें हैं जिसमे से एक सीट नॉर्थ गोवा की तथा एक साउथ गोवा की है और राज्यसभा की एक सीट है । गोवा राज्य में दो जिले और ग्यारह ताल्लुकाएं हैं । हमारी विधान सभा के माननीय अध्यक्ष श्री रमेश तावडकर हैं और उपाध्यक्ष श्री जोसुआ सौजा है। माननीय श्री प्रमोद सावंत जी राज्य के मुख्यमंत्री हैं । पहली टर्म में वे गोवा विधान सभा के माननीय अध्यक्ष भी रह चुके हैं और वे माननीय मनोहर पारिकर जी के देहांत के उपरांत से ही गोवा राज्य के मुख्यमंत्री के पद पर कार्यरत हैं । विधान सभा में टोटल 12 समितियां हैं । इसके अलावा हमारे यहां पर सिलैक्ट कमेटी भी है। आम तौर पर हमारे यहां प्रत्येक कमेटी में कम से कम चार सदस्य और अधिकतर आठ—नौ सदस्य होते हैं और एक वर्ष में लगभग 25 से लेकर 30 बैठकें तक हो जाती हैं ।

अधिकारी ने यह भी बताया कि हमारे यहां पर भी आवास योजना के अन्तर्गत आने वाले गरीब लोगों को मकान मरम्मत के लिए 3-5 लाख रुपये और नये मकान के लिए 5 लाख रुपये तक की सहायता राशि का प्रावधान है । इसी प्रकार से केन्द्र व हमारे प्रदेश की सरकार द्वारा भी गरीब व पछिड़ा वर्ग के लोगों के कल्याण के लिए बहुत सी जन–कल्याणकारी योजनाएं चलाई जा रही हैं । तत्पश्चात, गोवा विधान सभा के प्रशासनिक अधिकारियों ने अनुसूचित जातियों, जनजातियों एवं पिछड़े वर्गों के कल्याण के लिए चल रहीं विभिन्न कल्याणकारी योजनाओं के बारे में विस्तार से अवगत करवाया । मुख्य योजनाओं का वर्णन इस प्रकार है:– अनुसूचित जातियों, जन जातियों व पिछड़े वर्गों के कल्याण के लिए योजनाएं :--

समिति ने चाहा है कि गोवा विधान सभा की तर्ज पर जैसे कि वहां पर मैम्बर्स को सात ईम्पलाईज का स्टाफ दिया जाता है हमारी विधानसभा में भी मैम्बर्स का स्टाफ बढ़ाने पर विचार किया जाये ।

समिति के संपूर्ण दौरे के दौरान मैंने देखा कि गोवा राज्य कृषि तौर पर इतना सक्षम नहीं है परन्तु पर्यटन सैक्टर इतना मजबूत होने की वजह से गोवा की जी.डी.पी. हमारे राज्य से बेहतर है। अतः मेरा सुझाव है कि हमारें राज्य में भी पर्यटकों को बढ़ावा देना चाहिए तथा सरकार द्वारा उचित कदम उठाने चाहिए ताकि हरियाणा के पर्यटन को नई ऊंचाइयों तक पहुंचायाँ जा सके क्योंकि हरियाणा में भी पर्यटन के पर्याप्त स्त्रोत मौजूद हैं जिनको अच्छे ढंग से विकसित किया जा सकता है।

Procedure for dealing with implementation of the recommendations/observations of the Committee on the Welfare of Scheduled Castes, Scheduled Tribes and Backward Classes.

- (a) After presented the report to the Haryana Vidhan Sabha, copies thereof will be forwarded directly to the Administrative Secretaries concerned with the subject matter of the Report by the Secretary, Haryana Vidhan Sabha;
- (b) The Administrative Secretaries concerned with the subject matter of the Report will consider the recommendation of the Committee on the Welfare of Scheduled Castes, Scheduled Tribes and Backward Classes. A copy of the letter being endorsed to the Head of Department concerned simultaneously. General recommendation will be dealt by the Social Justice, Empowerment, Welfare of Scheduled Castes and Backward Classes and Antyodaya (SEWA) Department;
- (c) The Heads of Department/Administrative Secretary concerned shall furnish their comments on the recommendations of the Committee on the Welfare of Scheduled Castes, Scheduled Tribes and Backward Classes on receipt of the Report of the Committee;
- (d) The Administrative Department concerned will then take immediate steps for the implementation of the recommendations of the Committee concerning it. It will take the case to the Minister Incharge of the Department of the Council of Ministers as the case may be;
- (e) The case in which the Administrative Department does not agree with the recommendations of the Committee will be forwarded to the Secretary, Haryana Vidhan Sabha, with detailed reasons for comments. Then Secretary, Haryana Vidhan Sabha will forward these comments to the Social Justice, Empowerment, Welfare of Scheduled Castes and Backward Classes and Antyodaya (SEWA) Department to examine such case and offer their comments;
- (f) The Administrative Department will then take immediate steps for arriving at a decision in such cases referred to the Minister Incharge of the Department or to the Council of Ministers, if necessary, for incorporating in the Memorandum for the Council;
- (g) After taken the decision at the appropriate level, the same will be communicated to the Secretary, Haryana Vidhan Sabha by the Administrative Department by providing a copy to the Commissioner and Secretary to Govt. Haryana of Social Justice, Empowerment, Welfare of Scheduled Castes and Backward Classes and Antyodaya (SEWA) Department;
- (h) Cases involving disciplinary action and financial and other irregularities should be placed before the Minister concerned or the Council of Ministers, as the case may be even though the recommendation of the Committee on the Welfare of Scheduled Castes, Scheduled Tribes and Backward Classes is proposed to be accepted. The cases involving financial irregularities will invariably be decided in consultation with the Finance Department.
- (i) The Secretary, Haryana Vidhan Sabha will prepare statement showing the action taken on the Report of the Committee and place it before the Committee. Further comments of the Committee, if any, will be communicated to the Administrative Secretaries to the Government of Haryana for necessary action.

The Vidhan Sabha Secretariat will maintain a list of outstanding recommendations of Committee on the Welfare of Scheduled Castes, Scheduled Tribes and Backward Classes and periodically remind the Department concerned. Every effort should be made by the Administrative Secretaries/Head of Department to expedite the action on the recommendations/observations of the Committee and this work should be treated as a general rule on Top Priority basis.
