The Subject Committee on Education, Technical Education Vocational Education, Medical Education and Health Services for the year 2022-2023 consisting of nine members were nominated by the Hon'ble Speaker, Haryana Vidhan Sabha on under Rule 279-A of the Rules of Procedure & Conduct of Business in the Haryana Legislative Assembly.

The Chairperson of the Committee suggested that the local Administration make sure to involve in Vaccination campaign to the social organizations & Public representative as MLA's, ex-MLA's, Municipal Councilors and ex-Municipal Councilors of the society to motivate the common man for this noble act and should increase the Vaccination rate. The State has established 23 molecular labs for COVID RT-PCR testing in public healthcare facilities in each of the districts. Additionally, 26 private labs have been empaneled for testing. 		<p>Efforts to increase Covid-19 vaccination in Haryana-</p> <p>Various efforts and initiatives were taken to improve the COVID-19 vaccination:</p> <ul style="list-style-type: none"> ● Fixed COVID-19 vaccination sessions were conducted at all the health facilities. ● Near to home COVID-19 vaccination sites were created to cover the elderly and specially-abled beneficiaries ● COVID-19 vaccination Special sessions for vulnerable group, transgender, homeless, persons without ID, etc. were created. ● COVID-19 vaccination camps were organized at various temples, Gurudwaras, malls, mandis, dhabas, haat, schools, prisons to cover the beneficiaries. ● Work place sessions were conducted in Government offices, Factories, offices and also at construction sites.

Additionally, the availability of Oxygen in all the public health facilities has been ensured by establishing 92 PSA plants, LMO tanks and procuring adequate number of B Type Oxygen Cylinder (10223), D Type Oxygen Cylinder (6511), Oxygen concentrators (>5000), and setting up manifolds. It is stated that State of Haryana is self-sufficient in Oxygen requirement.</p>

During the course oral examination of Health Department, the matter of blood donation camps organized by private organizations was discussed and Committee found that there is not a proper record of blood donors in the concerned C.M.O. offices in the state. The Chairperson of the committee recommended that a proper record of Blood donation camps and donors and recipient with their mobiles nos. should be kept in concerned C.M.O officers so that the donor should get more satisfaction. The Committee directed Health Services Department that a proper monitoring	<p>The recommendations of the Subject Committee were discussed in a meeting held under the Chairpersonship of Member Secretary, Haryana State Blood Transfusion Council and it was opined that records of blood centers are confidential due to fiduciary relationship of blood center and blood donors. However, all the records are kept open for inspection by any competent authority i.e. any representative of Deputy Commissioner, Civil Surgeon, Senior Drug Control Officer, Drug Control Officer, etc. As per the National Blood Policy and Guidelines 2016, wherein at Objective no.4.1.5 it is stated that “<i>each blood centre shall create and update a blood donors’ directory which shall be kept confidential</i>”. This is a vital step in promotion and retention of voluntary blood donors in order to ensure adequate availability of safe blood.</p>

	<p>Department replied that in current year the dengue cases are more than previous years because the Monsoon season was longer that why 5377 cases were reported while in 2020 dengue cases reported 1377. He assured the committee that now Health Department is doing well in this field. There are 27 Testing labs in the State and in Government Hospitals there is no any Charges of dengue test. The Committee discussed the side effects of fogging also.</p> <p>The Committee recommended that the Health Department should make aware people about the side effects of fogging in the rural areas.</p>	<p>dengue cases and 13 deaths were reported in the State as compared to 1377 dengue cases reported in previous year. During the year 2021, the monsoon was longer than usual, leading to creation of mosquito breeding sources. Further, dengue control activities were also suffered to some extent due to involvement of field staff, particularly, MPHW (M) in COVID-19 vaccination and other control measures.</p> <p>However, the House-to-house visits are conducted by MPHW (M) to identify & eliminate in-house mosquito breeding sites.</p> <p>Health Department has taken all necessary steps for prevention & control of Dengue in the State. Some of the major activities conducted during 2021 are mentioned below:</p> <ul style="list-style-type: none"> • Dengue test is done free of cost in all districts. At present, a total of 27 Dengue Testing Labs are functional in the State, at least one in each district.

		<ul style="list-style-type: none"> ● In Private Labs, Rs. 600/- have been fixed for a recommended dengue test i.e. ELISAbased IgM and ELISA based NS1 test. ● With an aim to prevent mortality due to dengue, provision of free Single Donor Platelets (SDP) has been made for all dengue patients admitted in Government Hospitals since 2020. In previous years, Rs. 8500/- per unit SDP were being charged. ● For Private Blood Banks, rates have been fixed for providing platelets @Rs. 11000/- per unit SDP. This cost is also paid by the department for patients admitted in Government Hospitals. ● For prevention of dengue, focus is given on Source Reduction Activities i.e. identification & elimination of mosquito breeding sites through house-to-house visit as Aedes mosquito's breeding are mainly the house-hold containers/utensil where water remains stagnant but not the big pools, ponds, natural depressions etc. ● 420 Domestic Breeding Checkers were also deployed for strengthening of Source Reduction Activities. ● Fogging is not recommended as a routine method, as it has no residual effect. Case Based Fogging is done to kill the infected mosquito to prevent further spread.
		<ul style="list-style-type: none"> ● Public is made aware about hazards of Fogging and effect of source reduction activities through various IEC/BCC tools like pamphlets, hoardings, banners, miking, group meeting, WhatsApp, media briefing, etc. in events such as World Malaria Day, National Dengue Day, World Health Day, Anti-Malaria Month (June) and Anti-Dengue Month (July) celebration with involvement of public to sensitize them about the preventive & control measures of Dengue.
5.	The Committee discussed the matter of Thalassemia and Hemophilia patients. Thalassemia occurs when there is an abnormality or mutation in one of the involved in hemoglobin	<p>It is submitted that there are approx. 700 patients of Haemophilia and 1200 patients of Thalassemia registered in Haryana. The following facilities are already being provided to these patients:</p> <ol style="list-style-type: none"> 1. Free blood units to all the registered Thalassemia as well as

	<p>production. Hemophilia patients are an inherited blood disorder characterized by less oxygen carrying protein and fewer red cells in the body in normal. These diseases affect health system of the patients very badly and such patients have needed blood regularly. The committee showed great concerns about the crippled health of such patients who are suffering from Thalassemia and Hemophilia.</p> <p>The Committee recommended that Health Department should make a policy with the coordination of Haryana Shehri Vikas Pradhikaran Department. According to this policy the private Hospitals who have got land on subsidized rate from Haryana Shehri Vikas Pradhikaran Department should adopt such patients who are suffering from Thalassemia and Hemophilia for free/concessional rates treatment/medical facilities. The proper registration should be maintained by the concerned C.M.O's. The Department should also be proposed before the Government to provide the financial aid/pension to the patients who are suffering Thalassemia and Hemophilia disease. The financial aid/pension should be given to such patients whenever Thalassemia and Hemophilia diseases are identified and the conditions should be removed in this regard.</p>	<p>Haemophilia patients at Government and Private/Charitable Blood Centers.</p> <ol style="list-style-type: none"> Free Iron Chelating agents and Leucoreduction filters to Thalassemia patients in all District Civil Hospitals. Free Anti Haemophilia Factor (AHF) - VIII & IX are already being provided in all District Civil Hospitals. Additionally, the procurement of AHF-VII/FEIBA (Factor Eight Inhibitor Bypassing Agent) is under process and will be provided free of cost. These medical conditions are also included under the 'Right of Persons with Disabilities Act, 2016' and accordingly, those having more than 60% disability, are provided disability pension at the rate of Rs. 2500/- per month. 172 Hemophiliac and 265 Thalassemia patients are receiving disability pension. <p>It is also apprised that Hon'ble Chief Minister Haryana has announced monthly pension for the patients suffering with Thalassemia & Haemophilia during a public rally on 9th May'2022, for which department is processing the proposal.</p> <p>However, with regard to recommendations of Subject Committee for policy of providing free/concessional rate treatment/medical facilities by the Private Hospitals, which have been allotted land on subsidized rates; it is submitted that the Haryana Shehari Vikas Pradhikaran has already issued a policy for providing free/ concessional treatment to BPL and other categories. However, being the number of such hospitals very small, the possibility of taking the patients suffering with Thalassemia & Haemophilia under the ambit of Ayushman Bharat-PMJAY Scheme is under consideration, as there are more than 650 hospitals registered under this scheme.</p>

The Chairperson of the Committee discussed with</p>	<p>With regard to providing free education to patients suffering with Thalassemia and Haemophilia, it is submitted that the Department of School Education has confirmed that free education is already being provided to Thalassemia and Haemophilia patients in compliance of provisions of the Right of Persons with Disabilities Act, 2016.</p>

	<p>Health Department that a whole family has to suffer with the presence of such patients who are suffering from Thalassemia or Hemophilia.</p> <p>Therefore, the Committee recommended that the free education must be provided to the patients who are suffering from Thalassemia or Hemophilia. The Health Department should make a District-wise list of the patients and with the coordination of School Education Department & Higher Education Department make it possible to provide free education in Government Schools, Colleges and Universities of the patients who are suffering from Thalassemia and Hemophilia.</p>	<p>However, with regard to providing free Higher Education, the concerned Department has been intimated the recommendations of Subject Committee & requested to take necessary action vide letter dated 12.05.2022. The reply is awaited.</p>

HEALTH SERVICES DEPARTMENTS

Observations/Recommendations of the Committee

1. The Committee discussed in oral examination regarding the action taken report/steps taken by the Health Department during Covid-19, epidemic. The Committee had been directed the Health Department to increase the vaccination camp, appropriate preparation regarding Ventilators, Oxygen cylinders and Isolation centres for the patients whenever the Committee conducted its spot visit at Rohtak and Nuh (Mewat) during the Covid-19, epidemic.

Health Department explained that the Booster dose to the people of 18 years to 59 years has been given free of cost from 15th April, 2022 and appropriate steps have been taken regarding Covid -19.

2. During the oral examination the Committee discussed the matter of blood donation camps which were organized by private organizations. The Health Services Department had been directed by Committee that a proper monitoring system should have been there so that the sale and purchase of the blood can be stopped.

Health Department replied that the guidelines have already been prepared to monitor blood collection in the blood donation camps by the various NGO's/ organizations at district headquarters and have been circulated to districts for compliance. Four Regional Committees at Hisar, Faridabad, Rohtak and Karnal have also been constituted to monitor the activities of private/charitable blood centres.

The Chairperson of the Committee further recommended that all the Chief Medical Officers should have the complete record of the blood where its consumed. All the data should be kept safe in the concerned Chief Medical Officers headquarters. The sale and purchase of blood should be completely stopped. The Committee stressed that blood donation is a noble act for whole mankind and no irregularity should be in this connection.

3. The Committee discussed about the action taken report in the matter of Thalassemia and Haemophilia patients by Health Services Department. In its 7th Report the Committee recommended that Department should be proposed before the Government to provide the financial aid/pension to the patients who are suffering from Thalassemia and Haemophilia disease.

The representatives of Health Department told that recommendations of the Committee were also accepted by Hon'ble Chief Minister, Haryana and announced monthly pension for the patients suffering from Thalassemia & Hemophilia.

The Committee further recommended that all concerned Chief Medical Officers should maintain an adequate system to provide free medicine and free blood to the patients who are suffering from Thalassemia and Hemophilia diseases. A proper record of medicines should be maintained by the C.M.O. offices and signatures of the family members of the patients should be in office record.

4. The Committee discussed the matter of vacant posts in Government Hospitals. A large number posts of Doctors, Nurses and Paramedical staff are laying vacant. The Committee also considered the matter of shortage of Ultrasound & X-ray Machines in Government Hospitals which causes a lot of problems to the poor people.

The Committee recommended that Health Services Department should make serious efforts to fulfil the vacant posts of Doctors, Nurses and Paramedical staff very soon. The matter of the shortage of Ultrasound & X-ray Machines in Government Hospitals should also be solved.

SCHOOL EDUCATION DEPARTMENT

The Committee discussed its scope and functions and framed the following questionnaires:

1. How many students are being admitted in the State under Rule 134- A in the last two years? Supply the District-wise details of the students who got the admission under Rule 134-A to the Committee.
2. What is the criteria to seek admission in the State under Rule 134-A. Whether any regular monitoring Committee has been constituted to listen the complaints of the students?
3. What is the latest position of teaching/non-teaching staff in the in the Government Schools (Senior Secondary Schools, High Schools and Primary Schools) in the state Haryana?
4. What is the criteria being adopted by Haryana Government for giving scholarship to poor students in the Government Schools (Senior Secondary Schools, High Schools and Primary Schools) in the state? What is the income criteria of the concerned parents whose children are eligible to get scholarship in the Government Schools?
5. Whether the Books and school uniforms are being provided to the poor students in the Government Schools, if so, the details thereof?
6. How many Governments Model Sanskriti Schools are in the State at present? What is the criterion to open Model Sanskriti Schools? Give District-wise details thereof?
7. How many Governments Model Sanskriti Schools will be opened during the current financial year by the School Education Department? Give the District-wise details.

- No admission will be taken in ongoing Classes 10th and 12th
- Only students who are currently studying in Haryana and have a SRN (Student Registration Number) are eligible for admissions under Rule 134A.
- School leaving certificate from the previous school will be mandatory for admission under Rule 134A.
- Students with families of income less than or equal to 2,00,000 lakh per annum will be eligible for application under Economically Weaker Section (EWS).

The proof for EWS are:

- Income Certificate from the Tehsildar (Income certificate is valid for 1 year from the date of issue) valid at the time of admission or
- an Affidavit of income from Class 1 Magistrate valid at the time of admission.
- Students from Below Poverty Line (BPL) families can apply with a valid BPL Ration Card.

- The minimum eligibility for admission under 134A for **government school students** is 55% marks or above in previous class completed (Academic year 2020-21) examination.
- The minimum eligibility for admission under 134A for **private school students** is 55% marks or above in the assessment examination to be held on 21st November. The Assessment Examination will only be conducted for previous class completed for private school students. E.g. Exam will be conducted for Class 4 if a student is applying for class 5.
- No assessment test will be conducted for students applying in Class 11th
- In case of Children in Need of Care and Protection (CNCP) there is no requirement for any documentation of birth proof , parent id and address proof. Orders of the child welfare committee of the concerned district of a child as per the section 50(1) of the Juvenile Justice Act 2015 will be mandatory to avail admission under this category.
- Students are allowed to apply for and take admission in the same private school where they are currently enrolled.

**1. RAJIV GANDHI SCHOLARSHIP FOR HIGH/SENIOR
SCHOOLS (EEE)**

Rajiv Gandhi Scholarship was introduced during the year 2005-06. One student each in boys category and girls category in each school in the 9th to 12th classes who stood first in the preceding class will be awarded. Under the scheme Rs. 1000/- per annum each to the students of High and Senior Secondary classes (9th-12th) are given as incentive/scholarship to encourage brilliant students provided such students have got first division..

2. PUNJABI LANGUAGE

Punjabi has been declared as Second Language in the State. Under this scheme, scholarships are awarded to students on basis of merit in Punjabi subject in 10th class examinations conducted by Haryana Board of School Education, Bhiwani and continuing study Punjabi in the 11th class. The Rate of scholarship for students of 11th& 12th is Rs. 75/- per month.

3. HARYANA STATE MERIT SCHOLARSHIP SCHEME

The scheme was introduced during the year 2009-10 on Secondary Department.

The Scheme has been revised by the Haryana Govt. w.e.f. session 2014-15 (Exam held in March 2014). Now there is no limit of 700 students and now onwards all the students will get scholarship who obtained the minimum 95% marks and above (irrespective of the Urban & Rural area (Boys & Girls). The Rate of scholarship for students of 11th& 12th is Rs. 150/- per month.

**4. To provide Free Laptop under Haryana State Merit
Scholarship Scheme on the basis of Board Matric Exam conducted by
Haryana School Education Board**

This scheme was launched in the year 2015-16 on the Secondary Side The State Govt. has formulated a scheme to provide free laptop to the meritorious students on the basis of board matric exam

SCHOOL EDUCATION DEPARTMENT

Observations/Recommendations of Committee

1. The Committee discussed the matter of a large number of vacant posts in Government Senior Secondary Schools, Government High Schools and Government Primary Schools. The Committee observed that without sufficient strength of teachers it is not possible to provide good education in Government Schools. The Committee noticed that in every district the posts of Lectures and Teachers are laying vacant. Shri Shamsher Singh Gogi, Member of the Committee particularly raised the point that a number of Punjabi Lectures and Punjabi Teacher's posts are laying vacant. The Committee also discussed the vacant posts of teachers in Nuh (Mewat) with Additional Chief Secretary of School Education Department.

Therefore, the Committee directed the School Education Department that they should make serious efforts to fill up the vacant posts Lectures and Teachers in the whole state so that quality education in Government Schools can be provided. In connection with Nuh (Mewat) the Committee also recommended that some incentive to be given for the teachers who are willing to perform their duties in Mewat area. In connection with Mewat area the Committee gave a direction that the Education Department should recruit the teachers through Outsourcing Policy, Kaushal Rojgar Nigam or retired teachers so that study of the students not to be suffered.

2. During the course of oral examination with Education Department the Committee discussed the matter of distribution of Tab/Smart Phone's in the Schools. Additional Chief Secretary of School Education Department told that approximately Five Lakhs Tablets have been distributed throughout the state.

The Chairperson of Committee directed Education Department that they should ensure that the Tablets must be distributed in all the districts among the students of Haryana state. The remaining task of distribution must be completed within specific time so that students can take an advantage of this facility and after completing this process supply the detailed list to Committee.

3. During the oral examination of the Committee, it is also come into the notice to the Committee that infrastructure in Government Schools is not up to mark. The Committee discussed the matter of incomplete construction work in some Schools. Some of the Government schools have crumbling buildings. Although there is enough space but not sufficient funds to build up good buildings. Additional Chief Secretary of School Education Department told that construction work is continues process but as well as concerned of Government Senior Secondary School Assandh it is in final stage and Government has sanctioned Rs. 1,82,77,889/ for completion of all construction work.

The Committee also recommended that there is great need to improve the infrastructure of Government Schools in order to provide qualitative education and facilitate all the students.

4. The Committee considered that the strength of students in Government schools is declining as concerned of Private schools it is increasing day by day. The Committee also realizes that only poor children are going in Government schools. During the discussion one of the Member raised a question that the fee structure in Private schools is beyond the reach of poor people/common people.

The Committee recommended that the School Education Department should make more efforts to improve the standard of Education in Government schools so that the strength the students can be improved. The Committee also recommended that there should be a monitoring system in School Education Department which can check & control the fee structure of Private Schools and make it reasonable and accessible to poor people/common people. The Department should convey to the Committee accordingly.

5. During the course of oral examination of School Education Department, the matter of monthly stipends for Scheduled cast and Backward class students. School Education Department told that the monthly stipend is disbursed quarterly and it is revised rate w.e.f. 1.4.2013. Shri Shishpal Singh, a Member of the Committee raised the question about this and said the Stipends are insufficient.

The Committee recommended that rates of monthly stipends for Scheduled cast and Backward class students in Schools should be increased because ten years have been past.

11. Issuing/renewal/cancellation of LOI, NOC or Essentiality Certificate regarding establishment of Medical Education Institutions under Central Govt./State Govt./Semi Govt./Autonomous organizations and in Private Sector.

SPOT VISIT/INSPECTION AND MEETING AT KALPANA CHAWALA MEDICAL COLLEGE/HOSPITAL KARNAL OF THE COMMITTEE

The Subject Committee on Education, Technical Education, Vocation Education, Medical Education and Health Services was conducted a spot visit/Inspection and meeting with the Deputy Commissioner Karnal, the Director, Medical Education & Research Department, the Director General, Health Services, Director, Kalpana Chawla Government Medical College & Hospital and Chief Medical Officer, Karnal. The Committee visited all the units of Medical College and Hospital. During visit of the Committee Shri Shamsher Singh Gogi, Member of the Committee raised the issue of non-availability of super specialty services like cardiology, pediatric surgery, radiologist and nephrologist. He also demanded setting up of a Cath lab at the Medical College. The Committee also noticed the shortage of Paramedical staff in Hospital.

During the spot visit of the Committee at Kalpana Chawla Government Medical College & Hospital, Karnal some students of BSc. (OT) 1st year levelled allegations of harassment against the OT master at Anatomy Department. The students handed over a complaint to Chairperson of the Committee. Students alleged that OT master used to pass vulgar comments and made them sit for hours in OT without any reason. He also gave them an offer to go on a tour to Vrindavan from 22nd January, 2023 to 26th January, 2023 and when the students refused to go there, he started harassing them, the students told to the Committee. The visiting Committee said the allegations are very serious and Chairperson of the Committee interacted with all the students of BSc. (OT) 1st year in the classroom at college campus. After interaction with the students the Chairperson assured that a strict action would be initiated. The Committee directed the Medical Education & Research Department and the Director, Kalpana Chawla Government Medical College & Hospital to form an internal complaint committee of the College to inquire into the issue and submit a report within 15 days to the Subject Committee on Education, Technical Education, Vocation Education, Medical Education and Health Services of Haryana Vidhan Sabha. After the directions of the Chairperson of the Committee, the Director, KCGM sent OT master on one month leave. The OT master was also restricted from entering the College premises. The Committee visited the Thalassemia patients' ward and talked with the guardian of the patients about the facilities and medicine are providing in the Hospital. The Committee also visited Blood bank and Medicine store at Civil Hospital Karnal and discussed with the Director General, Health Services, and CMO, Karnal about the supply of medicines.

Later, the Committee visited the Civil Hospital, Government ITI Karnal and PHC Uplana district Karnal. Shri Shamsher Singh Gogi, Member of the Committee raised various issues related to the Civil Hospital and PHC, Uplana district Karnal. The shortage of doctors in PHC, building is lying abandoned and lacks cleanliness and there are no facilities for treatment of pregnant women here. On the issue of 100-bed Hospital at Assandh, the Director General, Health Services, Dr. Usha Gupta, informed the Chairperson that funds have been sanctioned for the new building of Hospital.

Observations/Recommendation of the Committee

1. The Chairperson directed the Civil Surgeon to visit the Trauma center and de-addiction centers, Karnal and check the record to avoid any irregularity.
2. The Committee discussed the matter of treatment under the schemes as Chirayu and Ayushman. The Chairperson of the Committee directed that to submit the record of the patients who got the treatment under Chirayu and Ayushman per month since December, 2022 to the Committee.

3. The Chairperson of the Committee directed Health Services Department that patients who are suffering from Thalassemia and Hemophilia should be treated passionately and they should be given all the facilities like blood and medicine etc. on priority basis.
4. During the spot visit at PHC Uplana, district Karnal the Chairperson of the Committee directed the Health Department that the issue of shortage of the Doctors and Paramedical Staff should be resolved soon and ensure to provide all facilities at PHC Uplana district Karnal so that the people of this locality can take the benefits of medical services there.

MEDICAL EDUCATION & RESEARCH DEPARTMENT

Observations/Recommendations of Committee

1. The Committee discussed with Additional Chief Secretary Medical Education & Research Department that this Department is established with the mandate to promote the quality of Medical Education for Under Graduate, Post Graduate in the State and Super- Specialties in medicine and surgery across the state. The Department stated that there are 12 Medical Colleges in the state apart from this four are under construction and three are in active phase.
The Committee desired to supply the progress reports of the Medical Colleges which are under construction and other three which are in active phase for the year 2022-2023 to the Committee at Haryana Vidhan Sabha.
2. During the course of oral examination, the Chairperson of the Committee asked about Pt. Deendayal Upadhyaya University of Health Sciences, Kutail at Karnal. The representatives of Medical Education & Research Department told that the DPR amounting to Rs. 761.51 Cr. has been approved by the Government. The University shall have the facilities of Super Specialty Hospital with 750 beds Academic Block for Post Graduate/Post-doctoral teaching (DM/MCH Courses) along with Research Departments like Biotechnology. It will be completed till 30th April, 2023.
The Committee desired that to supply the progress reports to the Committee of Pt. Deendayal Upadhyaya University of Health Sciences, Kutail at Karnal, Government Medical College & Hospital, Village Koriyawas, District Narnaul. The Committee also desired to supply the progress report to the Committee of Pandit Neki Ram Sharma Government Medical College Bhiwani.
3. The Chairperson of the Committee points out that the Committee visited Shaheed Hasan Khan Mewati Government Medical College Nulhar, Nuh and Bhagat Phool Singh Medical College Khanpur Kalan, Sonapat District. The Committee discussed widely all the issues like shortage of Doctors, Nurses and Paramedical staff and inadequate infrastructures in the Medical Colleges. The Chairperson of the Committee also asked the Department representatives that what we can do best for the students for their training and teachings in the premises of the Medical Colleges.
The Chairperson of the Committee strongly recommended all the observations made by the Committee during the spot visit of Bhagat Phool Singh Medical College Khanpur Kalan, Sonapat District and Shaheed Hasan Khan Mewati Government Medical College Nulhar, Nuh should be implemented seriously. After completion of the Observations/ recommendations of the Committee within the stipulated period, supply the replies to the Committee.
4. During the course of oral examination with Medical Education and Research Department the Chairperson mentioned that the scholarship and stipend are not sufficient for the students.
The Chairperson of the Committee recommended that the budget of scholarship and stipend for students in Medical Colleges in the state must be increased so that the adequate facilities can be made available for Medical Education stream students and convey to Committee accordingly.
5. The Committee discussed about shortage of Medicines in Hospitals which are under Medical Education and Research Department for example Shaheed Hasan Khan Mewati Government Medical College Nulhar, Nuh and Bhagat Phool Singh Medical College Khanpur Kalan, Sonapat District.

The Chairperson of the Committee directed the Department about to prepare a monthly report including the data of patients who come into the Hospitals. In this way it can be found out how much supply and demand for medicines per month. The Committee recommended that if the funds are insufficient for medicines in Hospitals, then funds can be transferred from other head of the Medical Education and Research Department because medicines are the essential part of human life.

6. The Committee visited on 21st January, 2023 at Kalpana Chawla Government Medical College & Hospital and received a complaint from B.Sc. 1st year (OT) Tech. Course, Batch 2022-2023 students against OT master (Pawan Kumar). The Committee then directed the Medical Education & Research Department and Director, Kalpana Chawla Government Medical College & Hospital to form an internal complaint committee of the College to inquire into the issue and submit a report within 15 days.

The Committee discussed on the report of internal complaint committee of Kalpana Chawla Government Medical College & Hospital which unanimously upholds that the allegations made by the complaints stands proved beyond reasonable doubt and all the allegations leveled against OT master falls under section 2 (n) sub clause (ii) and (v) of sexual harassment of women at workplace (prevention, prohibition and redressal) Act, 2013.

The Committee discussed widely on this matter and felt that due to accused OT Master, the girls students faced a lot of problems & harassment in Medical College Campus. The Committee recommended that OT Master (Pawan Kumar) is not fit for serving in this institute hence he is dismissed from services.

The Committee discussed its scope and functions and framed the following questionnaires:–

5. Actual expenditure incurred under each sub-head of estimates during the preceding four years.
6. Reasons for variations, if any, between the actual of the past four years and the current estimates.
7. Annual Reports, if any issued by the Department on its working.
8. Documents pertaining to current State's five years plan programme relating to Department and their implantation.

Based on this design and drawings, the tender document will be framed by the CPWD as per the directions of the Ministry of Education, Government of India. MOU between 111T Sonipat and CPWD has been approved by the BOG, 111T (PPP)-Sonipat.

The Guest classes of IIIT Sonipat in 3 branches namely Computer Science & Engineering/ Electronics & Communication Engineering and Information Technology with Intake of 30 seats in each branch were started in the Campus of National Institute of Technology (NIT) Kurukshetra w.e.f. the academic session 2014-15. At present IIIT Sonipat is functioning from the temporary campus of Techno Park of IIIT Delhi at Rajiv Gandhi Education City Sonipat. They are offering two undergraduate programs in Computer Science and Information Technology (4 years, Bachelor of Technology). PG Programs (M.Tech, MBA) and Ph.D is being started, for which approval has already been obtained. The sanctioned strength of students is 180 against which 175 students are enrolled and the total Strength of students is 600 in the campus.

**Review of the Annual Administrative Report of Department of Technical Education
Haryana for the year 2018-19**

.....

1. Objective

Adequately trained technical and professional manpower constitutes the most important component of the human resource which plays a pivotal role in the socio economic development of a State/Nation. The Department of Technical Education makes planning and promotes sustainable development of Technical Education in the state consistent with the National and State policies.

The Department prepares need based programmes for Technical Institutions (Polytechnics & Engineering Colleges) and also deals with the matters of Technical Universities in connection with ensuring adequate human resources and infrastructural facilities. It also ensures admissions as well as placement of students. It coordinates with various agencies at the State and National level for quality improvement and better interaction like the All India Council of Technical Education (AICTE), New Delhi, Ministry of Human Resource Development (MHRD), Govt. of India, National institute of Technical Teachers Training & Research Institute (NITTTR), Chandigarh, Confederation of Indian Industries (CII), All India Management Association (AIMA), Council of Architecture (COA), University Grant Commission (UGC), National Institute of Technologies (NITs), Indian Institute of Technologies (IITs) etc, various reputed industries and other experts from various organizations to provide quality education to the students at the level of Diploma, Degree, Postgraduation in the field of Engineering and Technology, Management, Pharmacy, Architecture and Hotel Management etc. The Department runs various welfare schemes for the students of Scheduled Castes, Girls, Physically Challenged Persons, socially and economically backward categories. The Department also assists the students for their proper placement in Industries for gainful employment besides providing further career guidance.

2. Present Status

At the time of inception of Haryana as a separate State in 1966, there were only 6 Polytechnics (Government-4 and Government Aided-2) and only one Engineering College at Kurukshetra (joint venture of State Government and Government of India) with annual intake of 1341 students. In Academic Session 2018-19, the number of institutions had grown to 309 with intake of 79694 students as per details given below:-

A separate training and placement cell established for industrial training and placement of the students in each Polytechnic, Engineering Colleges and Technical Universities.

3. Establishment of New Technical Institutions

The regulatory body for Technical Courses is All India Council for Technical Education (AICTE), New Delhi at the National level which grants approval for starting New programmes in Technical Institutions and for introduction of new courses/ programmes at the level of Diploma, Degree and post Graduation in Engineering and Technology and the other courses as specified by AICTE in consultation with the agencies concerned.

4. Constitution of Haryana State Technical Education Society (HSTES)

HSTES (formerly known as Haryana State Counseling Society-HSCS) in the Department of Technical Education constituted in the year 2007 for implementation of transparent and uniform procedure for admission to various post graduate, graduate and diploma courses in different disciplines of Engineering, Technology, Architecture, Town & Country Planning, Pharmacy, Management etc. in the State. The society implements rules and regulations for the admission of students to the various All India Council for Technical Education (AICTE) approved Technical courses in conformity with the policy approved by the State Government, Pharmacy Council of India, Council of Architecture, Universities of the State and other relevant bodies.

It is a self-sustaining body and meets its expenditure mainly through charging of fees for various services it renders. Every year, the society conducts following State Level Entrance Examinations:

On Line Entrance Test (OLET) for Lateral Entry in Diploma (Engg.)

On Line Entrance Test (OLET) for Lateral Entry in B.E. / B. Tech.

5. Constitution of Haryana State Board of Technical Education (HSBTE)

The Haryana State Board of Technical Education (HSBTE) was constituted through an Act which came into force on 6th May, 2008. Before this, the HSBTE was functioning with the executive orders as a part of the Directorate of Technical Education without having any legal force. The Additional Chief Secretary/ Principal Secretary Technical Education Haryana is the Chairperson/ Chairman of the Board. The Board has governing council as well as BOG both headed by the Principal Secretary Technical Education. The Secretary of the Board is appointed by the Government as the Chief Executive officer of the Board. He is assisted by the Additional

Secretary, Controller of Examination, Controller of Admin and Finance, Joint Secretary, 7 Deputy Secretaries, 15 Assistant Secretaries, Law Officer, Sr. Accounts Officer, Accounts Officer, Research & Statistical Officer, Hardware Engineer and Programmer etc.

HSBTE is a self Financing autonomous Board constituted for coordinating development of Technical Education in Polytechnic institutes in the State of Haryana by performing the following functions:-

- ❖ Well defined Academic Calendar notified for each Academic Year/Semester.
- ❖ Conductance of end Semester Examination for Polytechnics (Diploma Level) twice in a year in the month of Nov./Dec & May/ June. In the Academic Session 2018-19, (28633+62058= 90691) regular and reappear students appeared in December 2018 exam in 246 Polytechnics and (44941+54755 =99696) regular and reappear students appeared in May 2019 exam in 246 Polytechnics.
- ❖ A separate training and placement cell established for industrial training and placement of the students in each Polytechnics.

6. Technical Education Quality Improvement Programme Phase-III of Govt. of India
(World Bank Aided Project)

The Technical Education Quality Improvement Programme (TEQIP) of Govt. of India was conceived and designed as a long term project to be implemented in 10-12 years in three phases to support excellence and transformation in Technical Education in the country with the Assistance of World Bank. The Phase-I of the TEQIP Project started in March,2003 and finally closed on 31.07.2009. In the 1st Phase of the Project, 5 institutions namely (i) Kurukshetra University, Kurukshetra (ii) Chhotu Ram State College of Engineering, Murthal (iii) YMCA Institute of Engineering, Faridabad (iv) Guru Jambheshwar University, Hisar (v) Govt. Polytechnic, Nilokheri of the State participated.

In order to sustain the reform process and continue the development activities initiated through the TEQIP-I, a sequel project was planned by the MHRD, Govt. of India as TEQIP-II. It has a focus on the objectives to improve the overall quality of existing engineering educational programmes. The TEQIP-II was made effective from 06.08.2010 and closed on 31.03.2017 with a grace period of 4 months i.e. upto 31.07.2017. The TEQIP-II Project was a Centrally Sponsored Scheme with a fund sharing pattern of 75:25 between the centre and the State for Govt./Govt. Aided Institution respectively upto Financial Year 2015-16. From the Financial Year 2016-17 the funding ratio was changed as 50:50 between the centre and the state Govt./Govt. Aided institution and for private institution the funding ratio was changed 50:20:30 between the Centre and State and the Private Institution respectively. The following 6 institutions from the State of Haryana were competitively selected under sub-component 1.1 and 1.2 as under:-

Sub Component 1.1: (Strengthening Institutions to improve learning outcomes and employability of graduates:-

- (i) University Institutes of Engineering & Technology, Kurukshetra University, Kurukshetra (Govt. Institution)
- (ii) University Institute of Engineering & Technology, Maharishi Dayanand University, Rohtak (Govt. institution) and
- (iii) NC College of Engineering, Israna (Panipat) (Private Institution).

Sub Component 1.2 (Scaling-up Post Graduate Education and Demand –Driven Research & Development and innovation):-

- (i) Faculty of Science, Kurukshetra, University, Kurukshetra
- (ii) Faculty of Engineering & Technology, Deenbandhu Chhotu Ram University of Science & Technology, Murthal (Sonapat) and
- (iii) Faculty of Engineering & Technology, Guru Jambheshwar University of Science and Technology, Hisar.

In continuance to the development activities initiated through the TEQIP-I and II, a sequel project has been planned by MHRD, Government of India as TEQIP-III. It has a focus on the following objectives:-

- (a) Improving quality and equity in Engineering institutions in focus states viz. 7 low Income States, eight states in North-East of India, three Hills States Viz. Himachal Pradesh, Jammu & Kashmir, Uttarakhand and Andaman and Nicobar Islands (Union Territory).
- (b) System – level initiatives to strengthen sector governance and performance which included widening the scope of Affiliating Technical Universities (ATUs) to improve their policy, academic and management practices towards affiliated institutions, and
- (c) Twinning arrangement to build capacity and improve performance of institutions and ATUs participating in focus states.

The TEQIP-III Project will be implemented through the MHRD/Government of India as a Central Sector Scheme (CSS) wherein 100% funds will be provided as grants to the State Institutions & Affiliating Technical Universities (ATUs). The Technical Education Quality Improvement Programme Phase-III has been made effective from 01.04.2017 and is expected to be completed by 30.09.2020. The five Govt. /Govt. Aided institutions namely (i) Faculty of Engineering & Technology, Guru Jambhashwar University of Science and Technology, Hisar, (ii) YMCA Institute of Engineering Faridabad (now upgraded as J.C. Bose University of Science & Technology YMCA, Faridabad (iii) Deenbandhu Chhotu Ram University of Science & Technology, Murthal (Sonapat) (iv) University Institute of Engineering & Technology, Kurukshetra University, Kurukshetra and (v) Faculty of Science, Kurukshetra University, Kurukshetra who have participated in TEQIP-I and TEQIP-II have been provisionally selected through challenge method of selection on pre-defined eligibility criteria under sub component 1.3.

sub component 1.3 :- Twinning arrangements to built capacity and improve performance of participating institutions and ATU's in the focus state of TEQIP-III. These institutions will act as Mentor institutions for providing support to the focus state institutions selected under sub component 1.1 through twinning arrangements as well as for their own development. Each of above selected Mentor institutions will get a grant of Rs 7.00 Cr from the MHRD Govt. of India. The Memorandum of Understanding (MOU) between the Govt. of Haryana have also been signed by

Principal Secretary to Govt. of Haryana, Technical Education Department on behalf of the State (Govt. of Haryana) and Govt. orders as desired by National Project Implementation Unit (NPIU).

Noida have also been issued. The grants are being released to the institutions as per their Quarterly Action Plan by MHRD/Government of India.

7. Reimbursement of Tuition Fee to SC Students under the Scheme Scheduled Caste Special Plan (SCSP) of Haryana Govt.:

Under this Scheme, Tuition Fee to SC Students is being reimbursed. Actual tuition fee or Rs. 20,000/- whichever is less in case of diploma courses and actual tuition fee or Rs. 40,000/- whichever is less in case of UG/PG courses is being reimbursed to Haryana resident SC students, admitted through central counseling and whose parental annual income from all sources is between Rs. 2.50 lac to Rs. 3.50 lac per annum. In the session 2018-19, amounting Rs. 50,000 has been disbursed to 02 eligible SC students under this scheme.

8. Reimbursement of State Transport Facilities/ Train Pass under Scheduled Castes Sub Plan (SCSP) Scheme for SC Students:

All scheduled caste students of Diploma / UG/PG level of Technical Course having Aadhaar /UID number are eligible for this facility. However, scheduled caste students residing in campus/ hostels shall not be eligible for this benefit. In the session 2018-19, amounting Rs. 6.81 lakh has been disbursed to 367 eligible SC students under this scheme.

9. Scheme of Post Matric Scholarship to SC Students (Govt. of India Scheme) implemented by Welfare of SCs & BCs Department, Haryana:

The objective of the scheme is to provide financial assistance to the scheduled caste students studying at post matriculation or post-secondary stage to enable them to complete their education. Till the session 2008-09, this scholarship was disbursed by Welfare of SCs & BCs Department, Haryana to all the eligible SC students in Haryana. From the session 2009-10, Technical Education Department, Haryana is disbursing the scholarship under this scheme to those SC students who are studying in technical courses approved by AICTE/ affiliated to the State Board of Technical Education. Under this scheme the tuition fee, other allowances like student fund, examination fee, development fund and maintenance allowance etc are reimbursed only to those SC students whose parental annual income from all sources is upto Rs 2.5 lacs. During the financial year 2018-19, amounting Rs. 5.20 crores has been disbursed to 3846 claims under this scheme. This scholarship is disbursed in two installments in a year.

CRITIQUE of the Annual Administrative Report of the Technical Education Deptt. for the year 2018-2019

During the year 2018-2019, the No. of Technical Institutes were 486 i.e. 113 Engg. Colleges, 99 MBA colleges, 34 MCA colleges, 11 Architecture Colleges, 44 B. Pharmacy and 185 Polytechnics. The notable achievements of the Department are as under:-

Notable Achievements of the Department for the year 2018-19

National and State Projects:

1. Central Institute of Plastic Engineering and Technology (CIPET) Murthal, Sonapat has been established by Ministry of Chemicals & Fertilizers, Government of India. The State Government has provided 10 acres land free of cost as well as funds of Rs. 25.00 cr. for construction of CIPET Centre at Murthal, Sonapat. CIPET Murthal has been made functional from academic session 2013. Further, the proposal regarding expansion of existing Central Institute of Plastic Engineering and Technology (CIPET) Murthal, Sonapat is under consideration. The State Government will provide requisite additional land free of cost for expansion of CIPET Centre at Murthal.
2. Indian Institute of Information Technology (IIIT) is being established at village Kilohrad, district Sonapat by Ministry of Human Resource Development, Govt. of India & Guest classes of IIIT were started in the campus of NIT Kurukshetra w.e.f. academic session 2014-15. There is a proposal of starting classes of 1st year of IIIT Sonapat in the campus of Techno-Park in Rajiv Gandhi Education City, Sonapat (Extension Campus of IIT Delhi) from August, 2019. The construction work of boundary wall is in progress.
3. Indian Institute of Management, Rohtak has been established over 200 acre land at village Sunaria, District Rohtak by the State Government free of cost. The construction work of IIM campus Rohtak completed and the classes were shifted to its new campus during the academic session 2018-19.
4. National Institute of Design (NID) has been established at Umri, district Kurukshetra and its first academic session has been inaugurated by the Chief Secretary Haryana on 15.11.2016 in the campus of Govt. Polytechnic Umari. The construction work of NID campus is in completion stage through NBCC and classes of NID Kurukshetra are expected to be shifted in its own campus from the academic session 2019-20.
5. National Institute of Fashion Technology (NIFT) is being established in Sector-23 Panchkula by the Ministry of Textiles, Govt. of India. The construction work of NIFT Panchkula campus is expected to be completed by 7.11.2020. Five short term courses are being expected to be started in the temporary campus (building of Govt. Polytechnic, Sector-26, Panchkula) of NIFT Panchkula from August, 2019.
6. Two Extension Campuses of IIT Delhi are being established at Sonapat and Jhajjar. One Extension campus (Techno-Park) has been established in Rajiv Gandhi Education City Sonapat. The building was inaugurated by the Hon'ble Chief Minister, Haryana and Hon'ble Union Minister of State, Ministry of Human Resource Development. Another Extension Campus (Research & Development Centre) is being established at village Badhsa in Distt. Jhajjar by IIT, Delhi.
7. Technology Centre of Ministry of Small, Micro and Medium Enterprises (MSME) Centre, Govt. of India has been set up in the premises of Govt. Polytechnic Neemka, Distt. Faridabad in

August, 2017. Five diploma courses in Civil Engg., Electrical Engg., Mechanical Engg., Electronics & Communication Engg. and Computer Engg. have also been started from the academic session 2018-19 with due approval of AICTE

8. National Institute of Electronics & Information Technology (NIELIT) Centre has been setup temporarily in the building of Govt. Polytechnic, Umri (Kurukshetra) from 2017-18. Training programmes for diploma and degree students have been started in NIELIT Centre Kurukshetra from 2018-19.


9. Three New Govt. Engg. Colleges namely: State Institute Engg. & Technology Nilokheri (Karnal), Silani Kesho (Jhajjar) & Zainabad (Rewari) have been established with due approval of AICTE, New Delhi.

10. Two new Govt. Polytechnics at Sector-26, Panchkula and village Dhamlawas in District Rewari being established and expected to be made functional from the academic session 2019-20 after taking due approval of AICTE, New Delhi.

11. Establishment of Govt. Polytechnic in seven unserved Distt. by Govt. of India, Govt. Polytechnics Umri Distt. Kurukshetra, Hatnikund Barrage Distt. Yamunagar, Jatal Distt. Panipat, Dhangar Distt. Fatehabad and Nanakpur Distt. Panchkula have been established.

12. Another Govt. Polytechnic at Rajpur Block Sadhaura in District Yamuna Nagar is being established under the Scheme - Multi Sector Development Programme of Govt. of India and its construction work is expected to be completed by 31.12.2019.

Recommendations/ Observations of the Committee

1. The Committee discussed the matter of NIFT Sector-23, Panchkula which will be completed with the collaboration Central Government. In the same way the Ministry of Human Resources Development of India has permitted to establish Indian Institute of Information Technology (IITE) at Kiloahadath, Sonipat which has estimated cost of Rs. 128 crores.

The Committee desired to supply the progress report of both the Projects to the Committee.

2. During the course of oral examination with the representatives of Technical Education Department the Committee discussed the matter of Technical Universities and Polytechnical Colleges in the state. There are 299 Institutes including Technical Universities and Polytechnical Colleges in the state.

The Committee recommended and desired to supply the list of pending projects to the Committee.

3. The Committee discussed about J.C. University of Science and Technology, YMCA, Faridabad, Guru Jambheshwar University of Science and Technology, Hissar, Deen Bandhu Chhotu Ram University of Science & Technology, Murthal Sonapat. The Department representatives said that the strength of students and teachers are sufficient in these Institutions.

The Chairperson of the Committee recommended that the pending issues regarding J.C. University of Science and Technology, YMCA, Faridabad should be taken seriously and complete the pending work within stipulated period. A progress report sent to the Committee at Haryana Vidhan Sabha Secretariat so that it can be considered in the meeting.
