INTRODUCTION

1. I, the Chairman of the Estimates Committee for the year 1971-72 having been authorised by the Committee in this behalf, present this fourth report on the Budget Estimates for the year 1971-72.

2. A brief summary of recommendations/observations of the Committee is given in Appendix I. This summary is not exhaustive, and for full recommendations or observations of the Committee reference should be made to the main Report.

3. A brief record of the proceedings of each meeting has been kept separately in the Vidhan Sabha Secretariat.

4. The Committee are grateful to the representatives of the various Departments who appeared before them for oral examination.

5. The Committee place on record their high appreciation of the unstinted co-operation given by the Secretary, the Deputy Secretary, Haryana Vidhan Sabha and the staff.

REPORT

The Estimates Committee for the year 1971-72 was elected by the 1. Vidhan Sabha consisting of nine Members including the Chairman and notified, — vide Haryana Vidhan Sabha Secretariat Notification No. CB-EC-3/71/37, dated the 13th April, 1971.

Chaudhri Amır Chand Kakar, M.L.A. was nominated Chairman of 2. the Committee by the Speaker.

3. The Committee held 34 sittings (29 at Chandigarh and 5 at different places, namely, New Delhi, Madras, Pondicherry and Trivandrum. It selected the following Departments for the purpose of scrutinizing their Budget Estimates for the year 1971-72 :---

(i) Hospitality Organisation ;

(ii) Printing and Stationery ;

(iii) Health ;

(iv) Co-operation :

(v) Legislative ;

(vi) Animal Husbandry ;

(vii) Labour and Employment ; and

(viii) Development and Panchayats.

4. The Committee could only examine the material relating to the Hospitality Organisation and Printing and Stationery Departments.

The Committee also examined the Supplementary Estimates of the 5. Government of Haryana for the year 1971-72 (1st and 2nd instalments) and made their reports thereon to the Vidhan Sabha on the 2nd August, 1971 and on the 11th January, 1972, respectively.

HOSPITALITY ORGANISATION

The Hospitality department looks after the catering requirements of 6. visiting V.I.Ps High Dignitaries, Union Ministers, State Ministers, etc. It

runs three units at Chandigarh 1.e.,-Introduction.

(a) State Guest House ;

(b) New M.L.As Hostel ; and

(c) 30 Bays Cafetaria, Sector 17.

It also runs the following field units :----

- (a) Badkhal Lake and Suraj Kund.
- (b) Haryana Bhavan, New Delhi.

All these units also look after the work of State functions and departmental functions to the satisfaction of their patrons.

7. The following information in regard of the staff who have been put on various duties in the New M.L.As' Hostel was supplied to the Committee by the Hospitality Department :---

The Committee regret to note that inspite of a good number of staff put on various duties in M.L.As Hostel, the catering service is not satisfactory. Sometime the members have to wait for a long time for tea and food being

The Committee recommend that the management of the cafetaria and the Units run by the Hospitality Department be toned up and necessary steps taken to improve the catering service. Immediate steps be taken to achieve tangible result in the M.L.As Hostel in this behalf.

The Committee feel that the quality of food etc. supplied to Members

Surprise Inspection in the M.L.As. Hostel

in the M.L.As Hostel is inferior to that being served in the Haryana Bhavan, New Delhi, although the rates charged therefor are equal. The Committee brought to the notice of the

departmental representatives during the course of their oral examination that some members of the Vidhan Sabha had already sent complaints, both oral and written, in this respect and therefore those complaints should be redressed promptly.

The Committee recommend that immediate necessary steps be taken to improve the quality of food and service in the M.L.As Hostel. In order to achieve the object in view, one of the steps which the Committee recommend is that surprise inspection be conducted by a senior officer of the Hospitality Organisation from time to time and a complaint book be made readily available to the complaining M.L.A. for recording his grievance. Similarly a suggestions book be also maintained and action taken thereon by the department effectively.

9. The Committee feel that in the M.L.As Hostel generally adulterated milk and curd are supplied to the Members of the Vidhan Sabha. The Committee, therefore, recommend to the Government ensure that no adulteration in the food stuffs and parti-Adulteration. cularly in the milk and curd takes place.

10. It has been noticed by the Committee that whenever, during offsession period, any member of the Vidhan Sabha arrived in the M.L.As Hostel for attending Committee meetings in the Haryana Vidhan Sabha Secretariat or some private work he could not find readily available prepared lunch/dinner Preservation of prepared food. and as such he had to wait for a long time.

The Committee recommend that some prepared food for a few persons may be preserved in the refrigerator at all times in the M.L.As Hostel to meet the contingency.

The Committee also recommend that the Supervisor who has been detailed in the M.L.As Hostel be readily available upto twenty three hours every day for supervising the catering arrangements and also for issuing material to the staff for preparing meals for M.L.As who come to the Hostel by the last bus from Haryana.

The Committee have noticed that the Government suffer a loss of hundreds of rupees every year due to the breakage of crockery. The Committee, therefore, recommend that stainless steel utensils such as tumblers, plates (Thalis), Katrois etc., be provided in the M.L.As Hostel so that a huge expenditure being incurred on this item every year is reduced as far as it is possible.

12. The departmental representatives informed the Committee that the Cafetaria at Haryana Bhavan, New Delhi is running at a loss. The loss is being

Cafetaria at Haryana Bhavan, New Delhi. suffered on account of indefinite clientele, because sometime the number of clients was good enough, but on other occasions there was not sufficient number of guests, though in both the cases the establishment had to be maintained.

It was further explained that this was a temporary phase and with the passage of time the loss was bound to be made good.

The Committee recommend to the Government to consider the desirability of opening a canteen exclusively for the public at some suitable place in the Haryana Bhavan so that the loss suffered by the Cafetaria on account of indefinite clientele may be reduced, if not completely made good.

13. The Committee made an on-the-spot study of catering arrangements in the Haryana Bhavan, New Delhi. The Committee were impressed by catering

On-the-spot study of cataring arrangements in Haryana Bhavan, New Delhi. arrangements made by the Department in the Haryana Bhavan. The cleanliness being maintained in the Bhavan is also commendable.

The Committee are, however, pained to see the sorry state of affairs prevailing in the M.L. As. Hostel which merits greater attention at the hands of the Government because its utility is far greater to the elected representatives of the people than the Haryana Bhavan.

14. The Committee were of the opinion that if bonus, like private companies, were given to the employees of the Hospitality Organisation it would have in-

Bonus to employees

creased the efficiency of the Organisation it would have inthe sales and profits of the Cafetaria run by the Organisation. The departmental representatives informed the

Question of giving bonus did not arise. So far as the establishments at Badkhal and Suraj Kund are concerned, they are regular commercial undertakings and whatever incentive is given there to the staff, the sales will go up because the customers will be given better service.

The Committee recommend that some incentive may be given to those employees who boost the sales and the resultant profit of the Cafetarias or Restaurants.

PRINTING AND STATIONERY DEPARTMENT

15. In order to find out whether the Government Press is fully equipped to handle all the printing work of Government Departments efficiently and econo-

Object of examining estimates of Printing and Stationery Department. mically the Estimates Committee decided to examine the Budget Estimates of the Printing and Stationery Department for the year 1971-72.

At the time of reorganisation the entire Printing and Stationery Depart-16. ment was taken over by the Chandigarh Administration. It was only in June, 1968

that various Stores and their staff were divided between the Successor States and this Department got its share at 37.38 Present set-up of the per cent.

The Printing and Stationery Department of Haryana thus set up its following branches and started functioning under the supervision of Shri Tara Chand, Controller of Printing and Stationery :----

The Committee have noticed from the Statement showing the actual expenditure incurred under each sub-head during the years 1968-69, 1969-70, 1970-71 and estimates for 1971-72 that there has been a sharp increase in respect of some of the sub-heads. The Committee recommend that the department should analyse the causes of the sharp increase in expenditure.

18. On being enquired as to the staffing pattern of the officers immediately before the reorganisation of the State of Punjab and as it is at present in the State

Staffing pattern of the officers.

Sub-Head

of Haryana, the departmental representatives stated as under :--

"In the joint Punjab, Controller of Printing and Stationery was Head of the Department and the following gazetted officers were under him :----

- (1) Accounts Officer.—Who dealt with the work of Administration and Accounts Branch.
- (2) Deputy Controller, Stationery.—He was the Incharge of Stationery Branch.

(3) Deputy Controller, Printing Assistant Controller, 1st Shift Assistant Controller 2nd Shift Printing side of the Government Press.

(4) Deputy Controller, Publication and Forms.—He was the Incharge of the Government Book Depot and Forms Section.

- (5) Deputy Controller, Text Books.—He was the incharge of the Printing of the Nationalised Text Books and Text Books Cell.
- (6) Manager, Typewriter Workshop.—He was the Incharge of the Typewriter workshop.
- (7) Labour Welfare Officer.—He was looking after the welfare of the employees of Government Press.

After the bifurcation of the Department the Printing and Stationery Department of Haryana set up its own Stationery Branch, Form Section, Book Depot, Text Books Section and Typewriter Section etc. In these sections the work is being conducted as was done in the joint Punjab. The staff of these sections as existing in joint Punjab when divided amongst the three successors States and . U.T., it was found that the staff allotted to Haryana was insufficient to run these sections. Even then the work has been carried on with same staff and there is no scope for economy in expenditure of staff.

Government of Haryana has set up its own Printing Press and a Press for the printing of Text Books is also being set up. 5 New Text Book Sales Depots have been opened for the sale of text books. Similarly new workshops have been opened and typewriter machanics have been appointed at each district levels for the servicing/ repairs of typewriters. For all the works mentioned above there are only two officers in the Department—Controller and Assistant Accounts Officer. The work of these officers have increased very much. As such matter for the appointment of other officers is under consideration."

Keeping in view the workload and multifarious duties of the Controller and the scope for further expansion in the printing and other work of the Press, the Committee are of the opinion that it will be conducive to more efficiency if the matter regarding the appointment of Assistant Controllers is favourably considered by the Government.

19. The Committee have noticed that sometimes scarcity of Text Books is experienced in the market. The Book-sellers sell the books in blackmarket.

Nationalised Textbooks.

.

Sometimes it so happens that nationalised text-books are not available even during the examination days.

The departmental representatives informed the Committee that they print books on the basis of indent sent by the Education Department. They also informed that the stock position of text-books is intimated to the Education Department every month to enable them to assess their requirements and to send their requisitions for the reprinting of books. The work of printing of more text books is taken in hand on receipt of indent from the Education Department.

The Committee feel that due to the non-availablity of Nationalised Text Books in the open market, the study of many students suffers a lot. It results in a set-back to the cause of education in the State. The Committee, therefore, recommend that necessary steps should be taken by the Printing and Stationery Department in coordination with the Education Department to avoid shortage of Text Books in the open market and to ensure that the Nationalised Text Books are available in the market throughout the year. Black-listing of Private Presses.

1 20. On being enquired the Committee were informed that small mistakes do occur in the printing of text books for which deductions are made form the bills sent by the private presses and where the mistakes are many, pages of books are replaced and the expenditure incurred thereon is recovered from the bill of the Presses.

The Committee feel that sometimes mistakes of a serious nature escape unnoticed, perhaps at the proof-reading stage and thus get printed in the Text Books which give's bad name to the State.

. 1 in The Committee recommend that necessary steps be taken to ensure printing of errorless Text Books in the Government Press/Private Presses and to achieve this object the Government may set up a separate Committee to give its decision for black listing any private press which commits serious "type' of mistake in the printing of Nationalised Text Books.

The Committee surther recommend that in the case of mistakes , appearing in the Text books primed in the Government Press, responsibility, may be, fixed and suitable' action taken against those found at fault.

21. The department informed the Committee that the Haryana Government Press set up is a small one and only 25 per cent of the work is being done

Press Building.

therein. Second shift, according to them, will however, start working shortly and the same amount of work will be done more. This Press cannot be expanded further due to acute shortage of space. Land for

setting up a Government Press at Panchkula has, however, been acquired by the Government. Press for the printing of Text Books is being set up and in both the shifts 40 per cent of the total work will be undertaken therein and the romaining books shall have to be got printed from the private presses. They also informed that it is not possible to instal more machinery in the Government Press Building in order to undertake the printing of the work which is got done through the private presses. Besides, the printing work of electoral rolls will have to be got done form the private presses.

The Committee feel that the Government Press is not fully equipped as it has no building of its own. Due to it a good deal of Government work is being done by the private presses. The Committee recommend that immediate steps should be taken by the Government to construct its own building at Panchkula (District Ambala) expeditionsly so as to obviate the necessity of getting printing work done by private presses.

22. It has been noticed by the Committee that a large number of printing work of the Government such as Nationalised Text Books and the Debates

Private Presses.

of the Huryana Vidhan Sabha has to be entrusted to private presses. In their opinion the Printing and Stationery

Department should review this aspect from all angles in order to find out as to whether it would not be prudent and economical to prune the printing requirements of Government to the extent possible for which serious efforts should be made. 12

The Committee have noticed from the reply sent by the Printing 23. and Stationery Department that a large number of publications which are not in demand are lying in the Chandigarh Government Unsold Publications Book Depot and occupy a good deal of space.

The Committee feel that th' ir accumulation results in damage to the publications which leads to losses to the Government.

The Committee, therefore, recommend that the Printing and Stationery Department should inform the Departments whose publications remain unsold so that the Department concerned may take steps for their suitable disposal.

24. One of the important functions of the Printing and Stationery Department is to supply various items of stationery required by Govern-

Stationery ment Department's The Committee was informed that tenders are invited every year for the purchase of stationery articles by giving advertisement in newspapers. Each firm supplies the samples of their articles with the tender, which are selected by the Selection Committee keeping in veiw their quality and rates and accordingly contracts for the whole year are given ito those firms. They also informed that the articles of those firms, which are not found in order are rejected and securities of the firms which do not supply the articles, are forfeited.

The Committee are of the opinion that some articles of stationery supplied by the Printing and Stationery Department to various Governmen Departments are sometimes of low standard. The Committee, therefore, recommend that stationery articles of good quality be purchased by the Department which will not only prove economical but also save the wastage of stationery. The selection of articles should be made from utility point of view.

25. The Committee feel that the nibs, pen-holders, tags and pen-ink being supplied to Government employees in the State are not of good quality-

Supply of Fountain Pens to Government Employees. The articles of stationery lying on the tables .some times present an ugly look.

In the interest of cleaniness which is conducive to more efficienty in the Government work, the Committee recommend that fountain pens of a reasonably good quality be supplied to Government employees once a year. Pen-ink be supplied after every three months.

26. The Committee pointed out to the departmental representatives of the Printing and Stationery Department during their course of oral examina-

tion that printed copies of the Haryana Vidhan Sabha Debates are supplied to the members of the Vidhan

Sabha very late. Sometimes it takes months to reach their hands. The departmental representatives informed the Committee that the Vidhan Sabha Debates are being printed from the Government Press, Chandigarh Administration. The Committee were further informed that sometimes the printing work of Debates was entrusted to private presses in the interest of quick printing. This work will be undertaken in the Haryana Government Press after the installation of Monotype machines.

The Committee recommend that keeping in view the importance of Haryana Vidhan Sabha Debates immediate necessary steps be taken by the Department for installing Monotype machines. Some effective steps be taken to print the Debates and other literature of the Assembly on a Top Priority basis.

IMPLEMENTATION OF COMMITTEE'S RECOMMENDATIONS

27. The Committee held 14 sittings (up to the date of the drafting of this Report, i.e. 7th January, 1972) for scrutining the statements showing the action taken on the recommendations/observations made in their various Reports. They also orally examined the Administrative Secretaries concerned with the implementation of certain recommendations contained in their earlier reports.

An up to-date list of outstanding recommendations/observations from the Reports on the Budget Estimates of the Punjab Government for the years 1959-60, 1960-61, 1963-64, 1964-65, 1965-66, and of the Haryana Government for the years 1968-69, 1969-70 and 1970-71 is given in Appendix II.

The paragraphs of the Reports, and the budget estimates to which the outstanding recommendations relate have only been indicated in Appendix II. For the original recommendations/observations of the Committee, reference may be made to the main Reports. The latest observations of the Committee on the action taken by Government to implement the recommendations, in question, are, however, given in column 4 of the Appendix II.

It would be observed from the Appendix II that some of the recommendations which are still outstanding relate to the Budget Estimates for the years as far as back 1959-60. The Committee feel that their recommendations lose their value if they are not implemented in time or difficulties, if any, experienced by the Government in their implementation are not communicated to them at an early date.

The Committee strongly urge that immediate action should be taken to implement the outstanding recommendations as given in Appendix II and also those contained in this Report.

A brief summary of recommendations/observations of the Committee insofar as this Report is concerned is given in Appendix I. This summary is not exhaustive and for the recommendations or observations of the Committee reference should be made to the main Report.
