## INTRODUCTION

1. I, the Chairman of the Public Accounts Committee, having been authorised by the Committee in this behalf, present their thirty third Report on the Appropriation Accounts/Finance Accounts of the Haryana Government for the year 1986-87.

2. The present Public Accounts Committee was constituted vide Notification No. PAC-14/91/41 dated 26th July, 1991.

3. The Appropriation Accounts/Finance Accounts for the year 1986-87 were laid on the Table of the House on 21.2.1989. These accounts have disclosed excess over voted grants and charged appropriations as detailed in the Report. The Committee in their meetings held on 31st December, 1991 and on 13th January, 1992 considered the reasons for excess and surrenders furnished by the concerned departments and the evidence tendered by them.

4. A brief record of the proceedings of the meetings of the Committee has been kept in the Haryana Vidhan Sabha Secretariat.

**OBSERVATIONS/RECOMMENDATIONS OF THE COMMITTEE**

The main reasons for the excess expenditure over various grants were attributed to payments of arrears of D. A., Salaries and wages etc. and to various other reasons.

2. The Irrigation department incurred an expenditure of Rs. 81.79 lacs against the budget provision of Rs. 45.27 lacs for dewatering operations under grant '4—Revenue'. The department could not give satisfactory explanation for the excess expenditure. The Committee desired that responsibility of the concerned officers/officials may be fixed and it be informed of the same within a month.

3. The Committee further observed that suitable and effective measures be evolved to ensure that expenditure under various heads is kept within the budget allotment and whenever unforeseen expenditure is required to be incurred, funds are obtained in time by way of Supplementary grant or, if necessary, by an advance from the Contingency Fund.

4. Subject to these observations, the Committee recommend that excess expenditure detailed above may be regularised by the Legislature in the manner prescribed under Article 205 of the Constitution of India.
