2 The Committee for the year 2000 2001 undertook the unfinished work of the previous Committee(s) The previous Committee(s) during the oral evidence examined the representatives of the Department/Authority concerned The previous Committee(s) could not prepare and present its report to the House due to dissolution of the Assembly on 14 12 1999 A brief record of the proceedings of each meeting has been kept separately in the Vidhan Sabha Secretariat

## REPORT

### HARYANA URBAN DEVELOPMENT AUTHORITY

#### Historical Background

The Haryana Urban Development Authority (HUDA) a statutory body of Haryana Govt was constituted under the Haryana Urban Development Authority Act 1977 Before the constitution of HUDA the Deptt of Urban Estates which was established in the year 1962 used to look after the work concerning planned Development of Urban areas and it functioned under the aegis of the Town & Country Planning Deptt The functioning of the Urban Estates Deptt was earlier regulated by the Punjab Urban Estates (Development & Regulations) Act 1964 and rules made there under and all the various development activities used to be carried out by different departments of the State Govt such as PWD (B&R) Public Health State Electricity Board etc But it was observed that the involvement of severral agencies in the development of Urban Estates at various places had given rise to problems of coordination with the result that the growth of most of Urban Estates became slow and caused unnecessary dissatisfaction among the plot holders in particular and public in general Besides as the Deptt had to follow the financial rules and regulations of Govt the arrangement of finances and sanction of estimates took a long time and the development works had not kept pace with the required standards of physical development It was also considered that being Govt department it was unable to raise resources from various lencing institutions although there were various financial institutions in the country to finance urban land development programmes which could be availed of Thus in order to over come all these difficulties and to achieve the expeditious development of the Urban Estates it was felt that the Deptt of Urban Estates needed to be converted into such a body which could take up all the developmental activities itself and provide various facilities in the Urban Estates expeditiously Accordingly the Authority has taken over work which was being handled by individual departments The main functions of Haryana Urban Development Authority are as under —

- 1 To promote and secure development of Urban areas with the power to acquire hold and dispose off property both movable and immovable to contract
- 2 To acquire develop and disburse land for residential industrial and commercial purpose
- 3 To make available developed land to Haryana Housing Board and other Bodies for providing houses to economically weaker sections of the society and
- 4 To undertake building work

## **2 Administrative Set Up**

The Authority consists of a Chairman a Vice Chairman a Chief Administrator and other members (not more than 12 not less than 6) appointed under notification issued from time to time The HUDA has 6 wings namely Administrative Engineering Architecture Financial Legal and Monitoring The Administrative wing is headed by the Chief Administrator at the Head Quarters who is overall incharge and responsible for discharging functions of the Authority assisted by four Administrators posted at Panchkula Faridabad Gurgaon Hisar Urban Estates respectively and one Administrator at H Q (*Annexure A*) The Chief Administrator is guided by the policies framed by the Authority headed by the Minister incharge (designated as the Chairman of the Authority) of the Town & Country Planning and Colonisation Departments under Section 8 of the HUDA Act 1977 the Authority is competent to appoint committees for the purpose of securing the efficient discharge of the functions of the Authority and particularly for the purpose of ensuring the efficient maintenance of amenities and development projects Accordingly by virtue of these powers the Authority has constituted a number of Committees/Sub committees to take up decisions on various important matters

## **3 Functions of various wings**

### *(i) Estate Officers*

The entire State is divided into a set of 6 Urban Estates namely Panchkula Karnal Faridabad Gurgaon Rohtak and Hisar each one being under the charge of an Estate Officer The work of these six Estate officers is being looked after by four Administrators namely Panchkula Faridabad Gurgaon and Hisar The main functions of these Estate Officers are to sell developed and undeveloped plots of all categories of land and realise the amount of instalments All the financial receipts of transactions are looked after by the Estate Officers and channelised through the Accounts Branch of Head Office for expenditure on developmental activities These estate officers are also responsible for pursuing the matters relating to the construction activities within the frame work of construction and building rules applicable thereto The Administrators act as coordinators between various wings engaged in the planned urban development of the respective areas and are responsible for the implementation of various schemes/projects being executed in these areas The organisational structure of these Estates is as follows —

- (a) Administrator Panchkula
- (b) Administrator Faridabad
- (c) Administrator Gurgaon
- (d) Administrator Hisar

### *(ii) Administrator (Head Quarter)*

Administrator posted at H Q is overall incharge and responsible for co ordination among different wings of the Authority All the matters relating to Policy

matters and allotment of land to various institutions etc are also being dealt by him The financial Administrative Powers have also been delegated to him

*(iii) Establishment*

Establishment work of HUDA is looked after by the Secretary HUDA He also conducted the meetings of the Authority and rule brand of HUDA is also under him

*(iv) Engineering Wing*

The Engineering Wing is headed by the Chief Engineer assisted by Works Divisions which are scattered all-over the State The work of the Engineering Wing comprises of assistance in the selection of an area for development and its execution preparation of estimates for infrastructure construction of infrastructure for the development including Public Building Tree Plantations Development of Parks and maintenance of infrastructural services The Chief Engineer is the Professional Head of the Engineering Wing The entire state is divided into 5 circles 21 Divisions and 89 Sub Divisions headed by Superintending Engineers Executive Engineers and Sub Divisional Engineers respectively Similarly the Horticulture Wing also functions in the entire state under the administrative control of Administrators in their respective regions

*(v) Financial Wing*

The Financial/Accounts Wing is headed by the Chief Controller of Finance which comprises of Sr Accounts Officer at the Head Quarters assisted by Accounts Officers and Supporting Staff posted in all the Estates Circle Divisional Offices etc This Wing is responsible for the financial management of the Authority The existing system of accounting at all levels including that of Engineering Wing is basically on the pattern of PWD which is being replaced by the commercial system of accounts in such a way that it yields information required for planning and control of different functional areas and in the preparation of managerial reports Similarly the Planning and Control of material stores is of crucial significance which is being improved through introduction of performance budgeting materials and inventory planning and control based on net work and cost control techniques

*(vi) Architecture and Town Planning Wing*

The Architecture and Town Planning Wing has been established at the Head Quarters to look after the work of perspective Planning for establishment of new urban estates research and development of Zoning and Architectural controls the design of City Centres Planning of commercial areas Land Scape designing of parks and open spaces including nurseries and all other works of Urban design The wing is headed by the Chief Town Planner (HUDA) who is assisted by a Senior Architect and his staff for preparation of Architectural controls and Architectural designs of all buildings constructed by HUDA On the Architecture side there is a Land Scape Architect for designing parks open spaces and gardens and a Senior Town Planner and his supporting staff for town planning works The Architecture

and Town Planning Wing has also been entrusted with the job of designing and issue of advertisements in the newspapers regarding sale of sites in City Centres and Shopping Centres

(vii) *Monitoring Cell*

In order to monitor the progress of the developmental work done by the field offices on regular and timely basis a Monitoring Cell was set up at the Head Offices of the Authority which is headed by Deputy Economic & Statistical Adviser and supporting staff at the field level. The work relating to the regular systematic inflow of performance data and its appraisal for future planning of urban development is being done by this Cell.

(viii) *Legal Cell*

The HUDA is an organisation which deals with the acquisition and disposal of developed land for various purposes and accordingly legal complications of various natures do arise which are being taken care of by the Legal Cell of the Authority which is manned by a District Attorney with the necessary supporting staff both at the Headquarters and field offices.

(ix) *Land Acquisition divisions*

The acquisition of land for urban development is undertaken by four Land Acquisition Officers of the Urban Estates Deptt at the instance of Authority. The State Govt on the request of the Authority acquires land under the provisions of the Land Acquisition Act 1894 and after taking possession of land transfers it to the Authority on payment. The overall cost of acquisition and enhanced compensation if ordered by the competent court is paid by the HUDA out of its own funds.

#### 4 Staff Position

Study of information (*Annexure B*) supplied by the department revealed that number of posts were lying vacant since long. The main reason attributed by the representative of the Government was that in most of the cases posts were kept vacant due to disciplinary action pending against senior officials and due to ban imposed by the State Government. The Committee was however assured that a time bound scheme for expeditious finalisation of enquiry case has been framed and instructions issued to the Enquiry Officers to finalise the cases without any further delay. Suitable action will be taken against the Enquiry Officer for non finalisation of enquiries within time frame fixed by the Authority. **The Committee, therefore, recommend that all technical and non technical posts should be filled up at the earliest under intimation to the Committee.**

#### 5 Allotment of plots to Weaker Sections

The Committee appreciated suitable provisions for allotment of plots to the weaker sections of the society. However in actual practice the plots earmarked for allotment to weaker section of Society are generally cornered by other categories

of society by employing various tricks The Committee as such recommends that the rules for allotment of plots to weaker sections of society should be made more stringent and Committee be apprised accordingly so that weaker sections of the society are benefitted

## **6 Lack of infrastructure for migrated rural masses**

The Committee noticed that large number of rural masses are migrating to the cities every year which resulted into haphazard growth of the cities Due to lack of suitable infrastructure in cities rural masses are being cheated by the property dealers and do not feel comfortable in cities The Committee, therefore, recommends that colonies with suitable infrastructure for rural masses should be created for them in cities where they feel comfortable

## **7 Encroachment of HUDA Land**

The Committee observed that substantial land (about 203.02 hectares) owned by HUDA in various Urban Estates has been encroached by private people In certain cases HUDA land was encroached with the connivance of the concerned officers/officials The Committee, therefore, recommends that officers under whose charge HUDA land was encroached upon should be held responsible and criminal cases registered against them The Committee further recommends that in case of need relevant provisions of the Act may be changed Cases where encroachment was done by private people after the land was acquired by HUDA should be identified, responsibility fixed and expeditious steps needs to be taken to evict the land from private encroachers

## **8 Suspension and Enquiry Cases**

A glance at the Annexure C wherein details of suspension cases was given revealed that there was inordinate delay in finalising the suspension cases with the result that Authority is put to financial burdon in the shape of subsistence allowance In the cases of Shri VK Goel and Shri Ram Phal both JE's neither date of suspension nor date of reinstatement is given It is not clear from the information supplied by the Authority whether these employees are ever suspended or not

Shri N K Verma SDE and Shri Jagat Pal ADA are still under suspension for the last 3 and 4 years respectively whereas date of suspension in case of Shri Narinder Thakur JDM is not given

The Committee, therefore, recommends that reason for keeping Shri N K Verma, SDE and Shri Jagat Pal, ADA under suspension for such a long time resulting in payment of subsistence allowance for such a long period should be investigated and responsibility for delay be fixed Appropriate action against these defaulting officers/officials be taken promptly

In reply to the question of the Committee it was stated by the Authority that instructions have been issued to all the enquiry officers that they should complete the enquiry within a period of 3 months and in case of delay action will be taken against them

**Keeping in view this reply of the authority during oral examination, the Committee recommends that the final decision taken in all the 92 cases, as per list supplied by the Authority in respect of cases under Rule 7 & 8 where the comments/reply were awaited, may be intimated to the Committee at the earliest**

### **9 Disciplinary cases under Rule 7 and 8**

During the oral examination the Committee asked for the list of cases under Rule 7 and 8. The Authority supplied the list of such cases which are annexed at *Annexure D* and *Annexure E*. During the oral examination when asked about the delay in taking action in the cases at serial No 4 7 18 25 35 and 36 the Authority could not satisfy the Committee and admitted that there was delay on their part in expediting these cases and assured the Committee to expedite the cases. **The Committee taking a serious note of it recommended that all these cases be expedited in a time bound manner at the earliest and Committee be apprised of the action taken in the matter**

### **10 Visit of Officers/officials abroad**

Three officers visited abroad in the year 1995 and 1996. The details of which are as under

**The Committee desired to know the results of the said visits so as to see whether HUDA was benefitted as a result of foreign tours conducted by these officers. Tour notes of these officers needs to be submitted to the Committee**

### **11 Officers and officials visited various States in the country**

In reply to the question the departmental representative stated that information regarding names of officers who visited various States in the country on official tour alongwith purpose of visit and total expenditure incurred in regard

was being collected from field office but the information asked for was awaited at the time of finalisation of this report

## **12 Execution of various projects**

A glance at the detail of projects being undertaken by the Authority revealed that 24 projects were under execution of the Authority Some of these projects were approved as back as May 1993 The Authority had spent a sum of Rs 6350.59 lakh upto June 1999 The Committee expressed concern for not developing and finalising these sectors expeditiously which resulted into blockage of Funds as the work on these projects was stated to be in progress **The Committee desired to know the reasons of slow pace of development off these projects**

## **13 Sale of Commercial Sites**

During the oral examination when asked about the reasons for non sale of commercial sites at certain places it was informed that these sites were constructed 8-10 years ago The prices of these sites had gone up many fold due to the burden of interest on the cost of land and development charges of these sites The high cost of these sites was the main reason for their non sale Representative of the Government assured the Committee to dispose off these sites by reducing their rates

**The Committee took a serious note of it and recommended that all the commercial sites in developed sectors be disposed off and Committee be apprised of the action taken**

## **14 Loans from NCR**

HUDA had availed of loans from NCR on soft terms for development of residential/industrial sites adjoining to Capital Region of New Delhi As per information supplied by HUDA Rs 120.15 crore was availed upto May 1998 However the representatives of HUDA during oral examination intimated that it has availed loan of Rs 250/- crore **The Committee, therefore, recommend that the progress of expenditure of the schemes be supplied to the Committee to ascertain whether the loans were utilised for the schemes for which these were given by NCR**

## **15 Allotment of alternative plots**

As per information supplied by HUDA out of 1158 number of pending alternative plots only 263 plots were allotted leaving a balance of 693 disputed alternative plots The Committee expressed concern about the slow pace of allotment of disputed alternative plots **The Committee recommended that reasons for the disputes needs to be investigated under intimation to the Committee**

## **16 Loans given by HUDA**

In the written reply furnished by the Authority it was stated that under the directions of the State Government loans to HSEB and Sugar Fed were given

during 1980 81 and 1990 91 respectively without any security Total amount of repayment due and not received as on 31 3 1998 from HSEB and Sugar Mill Kaithal was Rs 242 lakhs and Rs 297 lakhs respectively

**The Committee express its concern that HUDA has been unable to recover its loan through State Government even after twenty years The Committee, therefore, recommends that the loans needs to be recovered without any further delay under intimation to the Committee**

#### **17 Funds received from Government of India**

In the written reply furnished to the Committee it is informed that a sum of Rs 129 03 lakh has so far been received against various schemes for utilisation of special grant recommended by 10th Finance Commission for development of satellite town around Delhi

**The Committee desires that complete detail alongwith place and purpose for which this grant was used may be furnished wrthin 2 months from the presentation of this report**

#### **18 Utilisation of Vehicles**


On the basis of details of vehicles supplied by HUDA it was seen that there were 15 and 38 vehicles of various types in the head office and field offices respectively In view of the ever increasing expenses on POL and repair and maintenance **The Committee recommended that austerity in these aspects needs to be observed by all concerned officers/officials and norms fixed for POL and repair and maintenance**

#### **19 Accounting Audit Mannual**

The Committee expressed its concern that the HUDA has not prepared its accounting and audit Mannual How internal audit parties conduct audit in the absence of Audit Mannual ? **The Committee, therefore, recommend that accounting and Audit Mannual be prepared immediately under intimation to the Committee**

#### **20 Finalisation of Accounts**

HUDA in its written reply intimated that accounts upto 1989 90 have been finalised while the accounts for the years 1990 91 to 1993 94 were under certificate or with the Accountant General Haryana It was also stated that finalisation of accounts for the period from 1994 95 to 1996 97 was under progress The Committee viewed the matter of arrears in accounts very seriously as the accounts were in arrears for more than 10 years In the absence of final audited accounts the financial status of the Authority could not be ascertained by the Committee **The Committee, therefore, recommend that besides intimating the reasons for delay in finalization of accounts, time frame to clear the back log be chalked out and the Committee be apprised accordingly**
