The Committee on Social Justice & Empowerment, Women & Child Development and Welfare of Scheduled Castes & Backward Classes for the year 2013-2014 consisting of Nine Members was nominated by the Hon'ble Speaker, Haryana Vidhan Sabha on 2nd May, 2013 under Rule 278 (1) of the Rules of Procedure & Conduct of Business in the House. Shri Devender Kumar Bansal, MLA was nominated as Chairperson of the Committee by the Hon'ble Speaker Two Special Invitees were also nominated by the Hon'ble Speaker to serve on the Committee

The Committee held 78 sittings during the year 2013-2014 (till finalization of the Report)

## SCOPE & FUNCTIONS OF THE COMMITTEE

The Committee on Social Justice & Empowerment, Women & Child Development and Welfare of Scheduled Castes & Backward Classes was constituted first time on 2nd May, 2013 under Rule 278 (1) of the Rules of Procedure and Conduct of Business in the Haryana Legislative Assembly and there are three following departments which comes under this Committee:-

- 1 Social Justice & Empowerment
- 2 Women & Child Development
- 3 Welfare of Scheduled Castes & Backward Classes

The functions of this Committee shall be ---

- 1 To scrutinize the demands for grants,
- 2 To examine the working of these departments and to suggest measures for improvement in administration and in different programmes/ schemes/ projects,
- 3 To examine legislation,
- 4 To advise Government on a question of policy or legislation on which Government may consult a Committee,
- 5 To discuss generally and formulate views on
  - a) State's Five Year Plan Programmes relating to these departments and their implementation,
  - b) Reports of Public Undertakings under these departments,
  - c) Reports of any statutory or other body, including any Commission of Inquiry, which are laid before the House relating to these departments, and
  - d) Annual Performance Reports of these departments

The Subject Committee shall not examine or investigate matters of day-to-day administration

The Committee discussed its scope and functions in detail. The Committee desired the departments to send the details of various Schemes, projects & programmes being undertaken by their departments.

\*\*\*\*\*

The Women and Child Development department sent a note on its activities which is as under .----

## 1. Coverage of all Slums under ICDS

Integrated Child Development Services Scheme is being implemented in 148 ICDS projects including 21 urban projects with the network of 25962 Anganwadi Centers including 512 Mini Anganwadi Centers. Under this scheme all the slum areas is being covered

## 2. Village Level Committee

The State Government has constituted Village Level Committee which has also been declared as a Sub-Committee of the Gram Panchayat under Section 22 of Gram Panchayat Act, 1994 for the development of women and children in order to, ensure greater participation and ownership of village community leading to improvement in service delivery At present 6033 Village Level Committees are functioning The function of these committees are as under .—

- The Committee will oversee village level implementation of all programmes relating to development of women and children and will receive feed back from beneficiaries under various programmes.
- It will maintain 'Child Tracking' record in every village in the Anganwadi Centres in order to monitor every child's birth survival, nutrition, health education and protection etc.
- The Committee would act as a catalyst in taking forward new initiatives such as supply of food items to Anganwadis through women Self Help Groups, mobilization of mothers to keep watch over quality of food and other services etc
- It will, in addition, deal with social issues pertaining to women such as domestic violence, dowry, female foeticide, early marriage etc

# 3. Status of Compensation to the victim of AWCs of Village Kaul of Kaithal District.

(1) As per Report of District Programme Officer, Kaithal one girl child was died and three children were injured on dated 24.07.2011 as the roof of the Anganwadi Centre of village Kaul collapsed The compensation of Rs.100 lac to the family of victim and Rs. 10,000 per family to the injured children were given by the District Administration through, Haryana Red Cross Society

Keeping in view the above tragedy instruction were given to the all District Programme Officers to ensure the safety of all the buildings in which AWCs are being run by the department

## 4. Status of Food supplied in AWCs.

(1) The priority of the State Government is to improve the nutritional status among children by providing quality Supplementary Nutrition to the ICDS beneficiaries. The State Government has brought about massive changes with regard to the implementation of Supplementary Nutrition Programme under ICDS The State Govt. is providing SNP containing an average nutritive value as per the norms prescribed 1 e. in the case of women & adolescent girls 600 calories and 18-20 gm protein, in case of children 500 calories and 12-15 gm protein and in case of severely mal-nourished children 800 calories and 20-25 gm. protein @ Rs. 5/- per mother, adolescent girls, Rs 4/- per child and Rs 6/- per mal-nourished child These rates will be revised under Strengthening & Restructuring of ICDS Scheme 1 e Rs.6/- per child per day for children, Rs 7 per day per pregnant & nursing mother/adolescent girl and Rs.9 per child per day for severely malnourished children. Supplementary nutrition is being provided to 11.00 lac children between 6 months to 6 years of age and 3 26 lac pregnant and nursing mothers along with other services. Procurement of food grains under Supplementary Nutrition Programme has been made by Govt of India under Wheat Based Nutrition Programmes (WBNP) at subsidized rates These food grains are being supplied to the Anganwadi Centres through CONFED and HAFED Two meals are being provided to the children in the age group of 3 to 6 years in the form of Morning Snack and Regular Hot Cooked Meal. Take Home Ration (THR) is being provided to Children below 3 years, Pregnant Women and Nursing Mothers The following instructions have been given to all the DPOs -

- a) To provide nutritive food to the beneficiaries with required ingredients and protein & calories value (Annexure 'DI')
- b) Quality and quantity of food served in the AWCs to be ensured
- c) Food supplied in the AWCs to be tested by the lab for ensuring quality
- d) The matter regarding provision of milk to the beneficiaries of the AWCs is under consideration under Strengthening and Restructuring of ICDS Scheme
- e) Food grains supplied under Supplementary Nutrition Programme in the AWCs is stored in the Storage Bin for ensuring the safety of the food Storage bin has been supplied in all the AWCs
- Cooking and Serving Utensils have been supplied in the AWCs for cooking of SN in hygienic conditions and for proper distribution of SNP to the beneficiaries

## 5. Infrastructure and facilities in AWCs.

1) Yearwise detail of construction of building of AWCs from the year 2005-06 and list of newly constructed/under construction AWCs is supplied to the Committee

#### ii) Drinking Water

Drinking water is available in almost all AWCs, however AWCs equipped with piped drinking water is available in 12874 of total functioning 25397 AWCs i.e. 51 % Joint Action Plan by PHE Department and WCD Department at district level has been prepared for providing this facility in the 6900 AWCs upto 30.06.2013 Remaining 5623 AWCs will be facilitated with Drinking water supply by 31.03.2014 so that the beneficiaries of the ICDS get safe drinking water

#### iii) Toilet Facility

A present 56 % AWCs are facilated with toilets It is worth mentioning here, that A WCs constructed by the department have provision of toilet in the lay-out plan At present 14235 AWCs are facilitated with toilet facility against 25397 functioning A WCs Besides, Joint Action Plan by Development & Panchayat Department and WCD Department at district level has been prepared for providing this facility in the 5699 AWCs upto 30.06 2013 under Nirmal Bharat Abhiyan of Total Sanitation Campaign. Remaining 5463 A WCs will be facilitated with Drinking water supply by 31.03 2014

#### (iv) Kitchen Facility

In view of Supreme Court directions to provide adequate space for cooking, storage facilities AWC lay-out Plan was got modified by making some additions/alterations by Chief Architect Haryana in January 2010 with the provision of cooking space, storing space for ration, water through, khurra, water tap and water supply and all AWCs are being constructed as per modified lay-out plan Besides, funds @ Rs 20,000/- per AWC were also released for earlier constructed 1996 AWCs to provide such facilities. So far funds for the construction of 3915 AWCs has been released by the department and all these AWCs have kitchen facility.

#### v) Fan & Electricity

At present there are 5478 AWCs having fans and 3328 AWCs are having electricity meters/connections. Funds of Rs 31470 lacs were released for providing water & electricity connections in already constructed 3147 A WCs @ Rs. 10,000/- per AWC This information is exclusive of Panchkula and Mewat districts as report is still awaited from them

#### 6. Disposal of cases of Juvenile by J. J. Boards

As per information received from the districts the total number of pending cases at the end of 30/06/2013 are 3525and the number of cases pending for the last four months are 737 Registrar General, Punjab and Haryana High Court, Chandigarh requested to issue directions to the concerned courts in Haryana to ensure to dispose of an inquiry in respect of a juvenile in conflict with law within the requisite four months and reduce the pendency of the cases

#### 7. Detail of Orphans Homes and CCl's along with name

For care, protection, treatment, development and rehabilitation of the children in need of care and protection, there are 101 Child Care Institutions in Haryana State run by Govt, Semi Govt and Private Organizations

- (a) CCIs run by Govt. and Semi Govt —
  State has 3 Govt. run and 6 Semi Govt. Children/ Shelter Homes
- (b) Children Homes/Child Care Institutions run by Private Persons/Organization —

87 private CCIs are functional in the State of Haryana. These Homes are spread across the state in all the 21 districts and covering 5701 children

#### Subject · Introduction of new recipes under Supplementary Nutrition Programme.

In continuation of this department's letter No 2120-39/CD-II/WCD/2010 dated 9-7-2010 on the subject cited above

Due to hike in prices of food commodities the following revised recipes are hereby introduced under Supplementary Nutrition Programme of ICDS scheme with immediate effect —

- 1. Panjiri (for children in the age group of 6 months to 18 months)
- 2. Poshtik Panjiri with milk for severely mal-nourished children
- 3. Mater (As morning snack for 3 to 6 years children)
- 4. Nutritious Mixture (-do-)
- 5 Stuffed Parantha. (As hot cook meal)
- 6 Puri with allu sabzi (-do-)
- 7 Sweet Rice/Khichari (-do-)
- 8 Meetha Dalia (-do-)
- 9 Gulgule/Sevian (-do-)

Stuffed Prantha, Puri with allu sabzi, Sweet rice, Khichri, Meetha Dalia and Gulgule/Sevaian will also be served as Take Home Ration (THR) for mothers, adolescent girls and children below 3 years.

All the recipes are formulated on the basis of 100gm wheat flour/rice to be given to each beneficiary per day In addition, Re. 1/- per day per beneficiary will be paid to

the SHGs and transport charges would be extra Composition, Nutritive value and cost of each recipe are as under -

The Committee discussed the manner of Food items being supplied in Anganwari Centers in the State The Committee directed the department to provide nutritive food with required ingredients and protein & calories value as per new recipes under Supplementary Nutrition Programme to the Children in Anganwari Centers and the instructions issued by the department in this regard may be followed strictly

The Committee further desired that record of checkings/supervision conducted by the department i e the number of checkings, by whom these were conducted and outcome thereof may be sent to the Committee

# The Welfare of Scheduled Castes and Backward Classes department sent a note on its activities which is as under :---

Social development has been ranked higher on the priority list of Government programmes since independence Social, economic and educational development of the Scheduled Castes has been given special focus by the Government of Haryana in the series of development Major activities and achievements of the Department for welfare and capacity building of Scheduled Castes, Backward Classes and Weaker Sections are as under —

#### SOCIAL DEVELOPMENT

To honor the girl child and to ensure that she is not a burden to the parents, it is befitting that the girls from relatively poor (BPL) Scheduled Castes families and daughters of widows are married gracefully. For this purpose, under the "Indira Gandhi Priyadarshini Viwash Shagun Yojna" a grant of Rs 31,000 is given to persons belonging to Scheduled/Denotified Tribes/Tapriwas Jatis (and also widows of all the sections of society living below poverty line and Rs 11,000 is given to the persons of other sections of the society living below the poverty line. It is now proposed to extend the scope of this scheme to cover girls from all families whose land holding is less than 2.5 acres or having income of less than Rs 1.00 lac per annum A grant of Rs 10,000/-will be given to girls from these families at the time of their marriage. Government of India provides 100% central assistance both for fresh construction and expansion of existing hostel upto 100 inmates for girls belonging to case of Government Castes studying in different classes ın Scheduled organization/Universities and 90% in case of NGOs, where the remaining 10% funds are to be borne by the NGOs The cost of construction of hostel is calculated on the basis of Public Works Department rates Central assistance on 50.50 share basis is provided for expansion of existing hostel for SC boys students to the State Government and the Central and State Universities In case of NGOs, the assistance is provided to the extent of 90% (45% Central share, 45% State share and remaining 10% is borne by the NGO) of the estimated cost, only for expansion of their existing hostels. In these hostels, scheduled caste students are provided free residential and furniture facilities For the year 2012-13, the amount is not yet to released by the Govt. of India under this scheme. The Committee held discussion with the representatives of the Welfare of Scheduled Castes & Backward Classes department in various meetings regarding different Schemes, projects & programmes being undertaken by their department for the Welfare of Scheduled Castes & Backward Classes peoples in the State and acquainted themselves with their activities

The Committee discussed with the Principal Secretary to Govt of Haryana, Welfare of Scheduled Castes & Backward Classes Department regarding problems faced by Scheduled Castes & Backward Classes peoples to avail various schemes implemented by the Department and directed to simplify the process of giving various benefits to them without much difficulty

#### OLD AGE PENSION AND BPL CARDS ETC.

The Committee orally examined Principal Secretary to Govt of Haryana, Social Justice & Empowerment Department and representative of Welfare of Scheduled Castes & Backward Classes Department on the issue of old age pension, BPL cards etc. After detailed discussion, the Committee further desired that the proceedings for invaliding the BPL Cards and other benefits like pension etc. if there is any, be stopped and the further proceedings of registration of FIR against those BPL Cards holder and pension beneficiaries may be stopped, may be the beneficiaries are wrong or right as it involves thousands of BPL beneficiaries and pension beneficiaries

The Committee also observed that the registration of the cases as well as action which is to be taken against the old age pensioners whose age is under dispute be stayed till further orders. Similarly, regarding BPL Card Holders who are under dispute of preparing/getting wrong BPL Cards their names may not be struck off from the BPL Cards Holder List and no case should be registered against them till further order. The detail regarding the facts of the BPL Cards on the basis of which BPL Cards were prepared have been called by the Committee from the concerned department. The motive of the Government is to help the poor persons they may be old age pensioners and BPL Card Holders irrespective of the fact they are getting the benefit by putting wrong facts

The Committee has received the above mentioned details The Committee on the basis of these details discussed the matter with the Director General, Rural Development Department & Joint Director, Welfare of Scheduled Castes & Backward Classes Department alongwith Deputy Commissioners of Ambala, Karnal and Panchkula Districts regarding deleting the names of persons for BPL benefits in the above mentioned Districts

After discussion with the officers the Committee observed that these are very poor persons living in miserable conditions. Therefore, no action against these persons may be taken and except those persons who are having agriculture land or otherwise well off in the society action must be taken by the department and the Committee may also be informed after taking the action in this regard.

The Committee orally examined Principal Secretary, Social Justice & Empowerment Department and Health Department regarding criteria/method adopted for verifying the age of a person for the purpose of getting old age pension. The Committee directed the department not to make any recovery from the persons who got their pension by error of age.



#### **ORGANIZATION OF CAMPS**

The Committee also discussed with the Director General, Welfare of Scheduled Castes & Backward Classes Department regarding implementation of various schemes The Committee observed that there are so many schemes for the benefits for the welfare of the Scheduled Castes in the State As per the information got by the Committee, this amount is not utilized for the beneficiaries because of the reason that the schemes which are already run by the Haryana Government are not brought in their knowledge These persons are not aware of the benefits given by the Haryana Government while so many schemes have been started for their welfare The Committee desired the department to organize the camps in different districts to aware the people of the BPL card holders and other persons concerned with these schemes regarding the schemes for their benefits run by the Haryana Government These camps may be organized within a period of one month and thereafter also as per the requirement and as per the availability of the funds

The action in this regard may be intimated to the Committee at the earliest
